Preparing for the Future

Just as many programs look to meet the changing needs of the 21st century, Freemasons must determine how they can continue to be a viable fraternity through the year 2000 and beyond. The world has not remained static during the past 93 years; nor can Masonic Lodges, if they wish to endure and thrive.

The image of Freemasonry is that we are an organization of older men, and truthfully the average age of our members is over 60. Added to this is the general decline in membership in all fraternal and service organizations. We must recruit and retain younger members to strengthen and revitalize our Lodges. Therefore, we must make our organization appealing to potential Masons. It is up to us to pass our tradition on to a new generation; yet at the same time, form new approaches to these traditions, that will allow younger members to truly feel they are a part of our fraternity.

In determining how to Prepare for the Future, MWBro Hugh Young appointed RWBro Gerald Webber, Junior Grand Warden, to take up the challenge and complexity of developing a strategy for renewal in the Alberta Jurisdiction. In determining how to strengthen the fraternity, Bro Webber's mandate was not to tear down existing structure, but to expand upon the structure to allow for new growth.

The Board of General Purposes supported Bro Webber's model for renewal which identified the problems/issues, and how to address the restrictions facing Freemasonry. The inaugural meeting scheduled in May, will bring together a seven member team from each geographical area. These enthusiastic Masons will have to do their homework as they develop a path on how to preserve Freemasonry in our communities with appealing membership, and how to stem the financial crises in Lodges.

We need to have our vision sprinkled with a dusting of reality. We need to set goals that are challenging, yet realistic, and can be achieved. We need to be creative in our approaches to Freemasonry and not dwell on the past. We need to be open to the challenges of change, as we move toward the untried. We need to measure our successes as we follow the paths of the dreams made.

Henry David Thoreau said: "If you have built castles in the air, that is where they should be. Now put foundations under them."

Our Renewal Program will be that foundation! A foundation to the Future.

As to the second: the 93rd Annual Communication of the Grand Lodge of Alberta, A.F. & A.M., one would think that nothing remains to be said about it. In approving any proposed amendment it does so only in regard to the constitutional regularity of the proposal and none of its members thereby expresses any personal opinion on the merits of it.

Canada Lodge No. 165

Notice of Resolution to Revise List of Officers to Include the Almoner

Canada Lodge voted in favour of a notice of motion that Section R3.1 of the Grand Lodge Constitution and Regulations be amended to add the office of Almoner to the list of officers of a Lodge and to read as follows:

- .1 The officers of a Lodge practising the Canadian Rite shall be: The Worshipful Master, The Immediate Past Master, The Senior Warden, The Junior Warden, The Treasurer, The Secretary (or Secretary/Treasurer), The Chaplain, The Senior Deacon, The Junior Deacon, The Director of Ceremonies, The Senior Steward, The Junior Steward, The Inner Guard and The Tyler, A Registrar, An Organist, A Historian, **An Almoner** and A Piper may be added.
- .2 The Officers of a Lodge practising the Ancient York Rite shall be: The Worshipful Master, The Immediate Past Master, The Senior Warden, The Junior Warden, The Treasurer, The Secretary (or Secretary/Treasurer), The Chaplain, The Senior Deacon, The Junior Deacon, The Director of Ceremonies, The Senior Steward, The Junior Steward and the Tyler, A Registrar, An Organist, A Historian, **An Almoner** and A Piper may be added.

Commercial Lodge No. 81

Notice of Resolution to Add Strategic Renewal Committee to Regulations

The Worshipful Master, Officers and Brethren of Commercial Lodge No. 81 move that a new section be added to the "Regulations" as permitted by Article 17 of the Constitution and the authority thereby given the Board of General Purposes as is described below.

New Regulation R1.7.17 Strategic Planning Committee

- .1 There shall be a Strategic Planning Committee consisting of the Senior Grand Warden (Chairman), Junior Grand Warden (Vice-Chairman), and seven Area representatives. The objectives of this committee shall be to provide long-term (5+ years) planning for the Jurisdiction.
- .2 The Committee shall consider the presence of four (4) area representatives and either Grand Warden to constitute a Quorum for the conduct of business.
- .3 The purpose of the committee shall be to evaluate the report of the committee on the Condition of Masonry, and all other relevant information deemed necessary, then formulate recommendations for the conduct and direction of the Craft as a whole, for the next succeeding five years, to be placed before the Board of General Purposes AND the Annual Communication, for ratification by the Members present.
- .4 The committee is required to provide an interim report to the Board of General Purposes at its fall meeting, and a final report at the May meeting of the Board of General Purposes. Its recommendations are to be published in the

preliminary proceedings of the next Annual Communication for the information of the Craft, and require approval of the majority of members present in order to become the "policy" of our organization.

.5 The only requirement for appointment to this committee or an area committee is two (2) years continuous membership as a Master Mason in a Lodge in this jurisdiction.

Concord Lodge No. 124

Notice of Resolution to Create a Millennium Museum Fund

- Whereas the Material Culture of our Fraternity is an integral component of the history of Alberta; and
- **Whereas** it can serve as a valuable medium for generating favourable public awareness and also as a valuable resource for Masonic Research and Education; and
- Whereas our Masonic jurisdiction is without a suitable repository for adequate stewardship of Masonic Memorabilia;
- **Therefore,** it is moved that the Grand Lodge of Alberta create a **"Millennium Museum Fund"** by means of assessing each member in our jurisdiction, two dollars per year for the five years commencing 1999 to 2003 inclusive; which fund will serve as a catalyst for the future accommodation of appropriate elements of the Material Culture of Freemasonry.

Calgary Lodge No. 23

Notice of Resolution to Revise the Master Mason Certificate

- Whereas the certificate now presented to Master Masons is a standard document of The Grand Lodge of Alberta, for both "Rites" practised in Alberta; and
- Whereas the Certificate presented to Master Masons does now depict eight (8) of the ten (10) Working Tools used by operative Masons; and
- Whereas the Working Tools are the focal point of major lectures in each of the three (3) degrees of the practised "Rites";
- **Therefore Be It Resolved** that the Master Masons Certificate be revised to include The Skirrett and The Trowel and thus complete the complement of Working Tools on the Certificate.

Strathcona Lodge No. 77

Notice of Resolution to Assign Their Previous Numbers to the Districts

That all Grand Lodge Districts be assigned their previous number to follow the District Name. In the case of amalgamated districts, the number assigned to be agreeable to the District. For example "Athabasca District No. 19."

The reasons for this motion are as follows:

There are hundreds of PDDGMs with collar jewels containing the District number that they represented. These PDDGMs should be introduced by their District number. Therefore "Athabasca District No. 19" recognises both the PDDGMs of District 19 and the PDDGMs of Athabasca District.

Second, the District History for 30 or more years all pertain to a District number and it is important that future Masons as well as DDGMs can relate to the continuance of this history by knowing that "Athabasca District" was originally "District No. 19." This continuation is important to the history of each district.

In order that the Motion may be properly formulated to accomplish what we have proposed, we would request an agreement with the Lodges' concern, for the following name and numbering system.

This numbering system will maintain reference to the Lodges 1990 District assignments and therefore should not present any objections.

The Relationship Between the Cardinal Virtues and the Tassels

Abridged from a paper by RWBro D. Roy Murray (81) The Four Cardinal Virtues and Tassels in the Lodge room—Is There an Appropriate Correlation Between the Two.

The reference to the Cardinal Virtues and the Tassels appears in the First Degree work. There appears however to be an inconsistency in the work in the various jurisdictions, in the sequence of naming the Cardinal Virtues and whether certain Cardinal Virtues relate to the Tassels. Some authorities list Justice first, while others will list Prudence first and so on.



In the Canadian Rite ritual the first reference to Tassels in a Lodge is given by the Junior Warden at the Tracing Board in the First Degree. The pertinent parts are:

"Pendant to the four corners of the Lodge are four tassels, which represent the four Cardinal Virtues, namely Temperance, Fortitude, Prudence and Justice... the whole of which tradition informs us were practised in an eminent degree by our ancient Brethren."

The lecturing Brother then points to the four tassels hanging in the corners of the Lodge room, naming them accordingly. The direction given to the tassels appears to be inconsistent among different Lodges. The lecturer often appears to start where it is convenient. If facing the west and using the right hand, the Northwest corner becomes "Temperance" and then moving through the four Cardinal Virtues clockwise, "Justice" is in the southwest corner. Although the Cardinal Virtues are not always mentioned in the same sequence, the candidate is exhorted to "let Prudence direct you, Temperance chasten you, Fortitude support you and Justice be the guide of all your actions."

The ceiling of the Grand Temple in Freemasons' Hall in London, England is adorned with mosaic figures in the form of angels with fulsome wings and these are given the names of each of the four Cardinal Virtues. "Temperantia" is in the southeast corner, "Fortitudo" in the southwest corner, "Prudentia" in the Northwest corner and "Justitia" is in the northeast corner.

Our Brethren in this jurisdiction, practising the Ancient York Rite, explain the Cardinal Virtues as being the "Perfect Points of your Entrance." The York Rite ritual does not refer to "Tassels."

In the (BC) Canadian Rite Ritual, the relationship between the Principal Points of Entrance, the Cardinal Virtues and the Tassels are summarized as follows:

Pendant to the four corners of the Lodge room are four tassels. These four tassels are described as referring to the four principal points — the guttural, pectoral, manual and pedal, and through them to the four Cardinal Virtues, namely, Temperance, Fortitude, Prudence and Justice, the practice of which are inculcated in the First Degree.

Conclusion

While there is insufficient proof to place any of the cardinal Virtues in any specific location, and there is no correct or authoritative positioning of the tassels, the positions of the allegorical figures in the Grand Temple in London may be offered as a guide.

The question also arises as to whether or not it is important to designate a special tassel to a specific Cardinal Virtue. The author believes there is no fixed connection between the Cardinal Virtues and the tassels, this enables the Candidate to moralize on the concepts rather than the position in the Lodge room.
