James Sutherland Woods was born in Edmonton on January 2, 1921 and attended the Edmonton Schools and the University of Alberta. He graduated with a law degree and joined the firm of Saucier, Jones and Associates in Calgary. He is married and has four children, two boys and two girls.

M.W. Bro. Woods was initiated into Zetland Lodge No. 83 on September 20th, 1956 and raised to the sublime degree on January 17th, 1957. He became the Worshipful Master of Zetland Lodge in the year 1962. After serving Grand Lodge for a number of years on a variety of Committees he was elected Junior Grand Warden at the Grand Lodge Communication in 1968. In June of this year he became Grand Master of Masons in Alberta.

George Randolph Sterling, a merchant in Benalto, Alberta, was elected Junior Grand Warden at the Grand Lodge Communication in June. He was born in Perivale, Ontario on October 1st, 1906. His Masonic career began in Carbon, Alberta when he was Initiated and raised in Carbon Lodge No. 107 in 1927. In 1937 he Affiliated with Kenilworth Lodge No. 29, Red Deer and was its Worshipful Master in 1940-41. When Beacon Lodge No. 190 was organized in Red Deer, he became a charter member. He has served Grand Lodge for a number of years on the Higher Education Bursary Committee. For the year 1952-53 he was the District Deputy Grand Master of District No. 4. In addition to his extensive Masonic activities, R.W. Bro. Sterling has taken a very active part in church and community life.

#### **GRAND MASTER'S MESSAGE**

At my installation in June, I announced the theme of this jurisdiction for the ensuing Masonic year: "Plan for Progress." Having called upon the Craft to plan it is only right that your Grand Master should do likewise and I assure you that there are sketches on the trestle board that will keep the brethren occupied and, I trust stimulated and invigorated.

The theme for the year will be elaborated upon in the fullness of time but for the present a word of caution is in order. To plan for progress does not mean to abandon the tried and true methods of the past merely for the sake of expediency. To plan for progress properly we must seize upon the finished building stones of the past and so arrange them as to build a super-structure in keeping with the present age. In keeping, but fixed firmly on the foundations laid out in conformity with the ancient landmarks.

The Italian historian Francesco Guicciordine said "Past things shed light on future ones; the world was always of a kind; what is and what will be was at some

other time; the same things come back but under different names and colors; not everybody recognizes them, but only he who is wise considers them diligently." Thus it should be in Masonry. It must adapt to the times without any fundamental change in its purpose and meaning. J. H. Plumb in The Death of the Past, poses these problems as lying at the very heart of our society. "Can men face the future with hope and resolution without a sense of the past. And if not, can a new past, truer than the old, be manufactured to give him a like sense of confidence." I suggest that these problems are at the heart of the Craft today, in all Grand Jurisdictions. I further suggest that no past can be manufactured which will give us any confidence greater than that which we now possess.

To Plan for Progress is to promote the fundamental principles and tenets of Freemasonry in an age of advanced technology, of almost absolute materialism and of hunger for the resurrection of the God so glibly claimed to be dead.

This is the challenge. Let us take it up!

(This column will appear in the Bulletin when questions regarding Masonic Custom, Usage and tradition are submitted to the Chairman of the Editorial Committee.)

Question—I noticed in the Grand Lodge Installation Ceremony and at meetings since Grand Lodge that our recently appointed Grand Secretary is given the title "Very Worshipful" whereas the previous holder of that office was referred to as "Right Worshipful." Are we downgrading this very important office?

Answer—No, the office is not being downgraded. If you paid careful attention to the Installation of the Grand Secretary you will remember that he is told that his office, by tradition and by direction, has become most significant both from the point of view of our own jurisdiction and also because of the constant contacts that he must have with world wide Freemasonry.

The Grand Secretary has the title "Very Worshipful" in accordance with our Constitution (Section 6). This is the rank that is given to appointed officers of Grand Lodge. The Grand Secretary is appointed by the Board of General Purposes and the appointment is confirmed by the Grand Lodge Communication (Section 23). The "Right Worshipful" rank is conferred on elected officers of Grand Lodge.

R.W. Bro. E. H. Rivers, our Past Grand Secretary. had the rank of "Right Worshipful" before he was appointed to the office of Grand Secretary in virtue of the fact that he was elected Grand Registrar at one time in his Masonic career. V.W. Bro. M. P. Dunford had not held an elective office and hence his title. In some jurisdictions (e.g. Saskatchewan) the Grand Secretary is a Past Grand Master and he retains the rank of Most Worshipful.

It may be that the importance of the office of Grand Secretary is sufficient that a higher rank should be attached to it especially because the Grand Secretary is constantly required to associate with brethren of distinction. To accomplish this the Constitution would have to be amended and there is a way to put the amendment before Grand Lodge if the questioner is concerned about the issue.

Our recently invested Grand Secretary, V.W. Bro. M. P. Dunford was born in Shaunavon, Saskatchewan on February 13th, 1924 and later moved to Coleman, Alberta where he worked with a coal mining company. He was initiated into Masonry in Summit Lodge No. 30 (now Rocky Summit) on September 7th, 1951 and raised to the third degree on November 2nd, 1951. He was Worshipful Master of Summit Lodge in 1959. In 1964 he was appointed assistant to the Grand Secretary and later Assistant Grand Secretary. He is affiliated with Bow River Lodge No. 1 and was Grand Pursuivant in 1965-66. One of V.W. Bro. Dunford's great contributions to Masonry is the work he has done on the Banff Spring Workshop. He has been its secretary and organizing genius since the inception of the Workshop.

R.W. Bro. E. H. Rivers was installed as Grand Secretary of the Grand Lodge of Alberta on Tuesday, September 22nd, 1953 in Highlands Lodge No. 168 by M.W. Bro. Wm. H. Jackson, who was then the Grand Master. He served the Grand Lodge from that date until his retirement at the Grand Lodge Communication in June. In his capacity as Grand Secretary he had a detailed knowledge of all parts of this jurisdiction and was widely known throughout Canada and in many parts of the world. Other Masonic bodies used his talents for organization when he acted as the Secretary of the Canadian Conference of Grand Lodge Officers and of the Banff Conference. A tribute to R.W. Bro. Rivers is contained in the Grand Master's Address which will be published in the Proceedings. The Brethren should also read R.W. Bro. Rivers reports which, at the end, has his message to the jurisdiction.

#### **RECOGNITION FOR SERVICE**

There have been a number of enquiries concerning the plans that are being made to recognize the eighteen years of service given to the Grand Lodge of Alberta by the Past Grand Secretary, R.W. Bro. E. H. Rivers. When the resignation of Bro. Rivers was received the Grand Master, at that time, M.W. Bro. Dr. E. J. Thompson, appointed a committee of three to report to him concerning proposals in this regard. The committee reported and the Finance Committee has approved the necessary expenditure. The following are the ways in which his service will be recognized:—

- 1. R.W. Bro. Rivers will be awarded the rank of a Past Grand Master of the Grand Lodge of Alberta with the title of Most Worshipful and with all the privileges of that rank. This cannot be done constitutionally without a notice of motion. The notice of motion was given by M.W. Bro. Wm. Ireland at the last Grand Lodge Communication and must receive unanimous approval of the 1972 Grand Lodge Communication.
- 2. The salary of R.W. Bro. Rivers be continued until the end of September 1971.
- 3. R.W. Bro. Rivers and Mrs. Rivers be invited to enjoy an expense paid holiday, preferably a cruise, as a gift of the Grand Lodge. This likely would take place in late Fall or in the Winter.
- Early in September the Grand Lodge will arrange a Testimonial Dinner for R.W. Bro. Rivers to mark officially the retirement.
