#### **GRAND MASTER'S MESSAGE**

Brethren, the Annual Grand Lodge Communication will be held on June 21 - 22, 1974, at the Hotel Macdonald in the City of Edmonton. The change in date was approved last year by the members of Grand Lodge.

Your Grand Lodge Officers have reviewed the format that has been in use for the annual communication and have made some changes in order to fit the new time frame. Ballot boxes will be open at 7:00 p.m., June 21, 1974, until 10:00 p.m. Grand Lodge will open at 8:00 p.m. and adjourn at 10:00 p.m. The ballot boxes will reopen at 8:00 a.m., June 22, 1974, with Grand Lodge reconvening at 9:00 a.m. The ballot will close at 11:00 a.m. It is our hope that our business will be completed by 12:00 noon. Luncheon will be served in the Hotel Macdonald. The installation of your Grand Lodge Officers will commence at 2:00 p.m. to be completed at approximately 4:00 p.m. The banquet will follow at 6:30 p.m. in the Hotel Macdonald.

In order to improve our communication with each other it is planned to have a normal lodge arrangement. There are notices of motions, reports of committees, and items of interest to the craft that must be thoroughly discussed and we urge the participation of all brethren. Only by this participation can you assure Your Lodge that

they are adequately represented. It will be necessary to have the co-operation of all brethren in being seated at the time of commencement of each session of Grand Lodge so that our time will be productive.

This year we have the opportunity of attending the banquet and honouring our new Grand Master and his officers. This should be a fitting climax to our proceedings. Our guest speaker is M.W. Bro. N. Mussallem, Past Grand Master of British Columbia, who I am sure will provide us with a most enlightening address. He is known for his sense of humour as well as his scholarly attributes.

I request that each Master, and each of the Wardens, of every lodge remember their obligation to attend the Grand Lodge communication. The Past Masters and Master Masons should also make every effort to be present and join in the discussion. Finally Brethren, the arrangements have been made, the business for your consideration is prepared, now you must decide what is to be done. Let us now make our commitment to participate.

#### THE UNIVERSAL LEAGUE OF FREEMASONS

At the request of the Grand Master we print for the information of Masons in Alberta, who may not have heard his letter read in open Lodge, his ruling concerning the so-called Universal League of Freemasons —

First of all a quotation from the Report on Fraternal Relations given by M.W. Bro. S H. Hardin at the last Communication of Grand Lodge —

"We would remind Masons at large that The Universal League of Freemasons is indiscriminate in its selection of members from Grand Lodges regarded as patently irregular, and hence not recognized by regular Grand Lodges. Edicts and resolutions have been issued against membership in this organization by many Grand Lodges, including the Grand Lodges of Texas, Pennsylvania, Massachusetts, Georgia, Quebec, England and Ireland".

Secondly the ruling

I, therefore, declare The Universal League of Freemasons to be a clandestine body and its members to be clandestine masons, and warn all Masons in the Jurisdiction of the Most Worshipful The Grand Lodge of Alberta that they may not become members of the said league or communicate Masonically with it or any member of it. All brethren are reminded that under Section 800 Par. (11) of our Constitution, Masonic communion with Clandestine masons is a Masonic offence.

#### FROM ONTARIO

A number of Brethren have been kind enough to write to let us know that they appreciated the Directory of Lodges that was printed in the Bulletin. From Ontario comes a letter written by Bro. J. E. Westbrook requesting a copy of the Directory and saying that three brethren were driving through from Ontario for the Masonic Spring Workshop and intended to use the Directory for help in making visits to Lodges on the trip. We were unable to get this note in before the Workshop but we did send the Directory. We hope Bro. Westbrook and company were able to visit lodges and we are sure they were welcomed warmly if they did. In addition we know that they found the Spring Workshop exceedingly worthwhile.

#### FROM EAST AFRICA

Bro. Dr. F. C. Sood who is now living in Calgary and is a member of Jubilee Lodge No. 173 sends along a notice of meeting of Lake Lodge No. 5022 which belongs to the District Grand Lodge of East Africa under the United Grand Lodge of England. The Lodge was to be opened at 6:00 p.m. and tyled at 6:30 p.m. They were to confer the M.M. Degree on some brethren who were initiated nearly a year before. Bro. Sood enclosed a very interesting paper which he gave to the District Grand Lodge of East Africa. We hope to be able to use it in a future issue.

#### THE LEFT FOOT

In the March Issue of the Bulletin we asked brethren interested in research to send us their findings regarding the instruction to a candidate to commence his approach to the Altar on his left foot. In the April issue we printed a few replies. Since then the following opinions have been received —

## From Bro. Edward R. Rogers, Cavell Lodge No. 125

The question asked "Why is the first step in Freemasonry taken with the left foot"? This stirred my memory and I consulted my file of "ARS QUATUOR CORONATORUM" and found an extensive reference to this same subject in volume LXXVI for the year 1963, pages 225 and 226, and quote briefly from this source:

"Thus it seems fairly certain that the three steps were in use before 1730, and although we do not know how many there were for each degree, or how they were taken it would appear that only three steps were known ... Note, there were then only the first three steps, but they still remained without verbal or written explanation or symbolism ..... The extraordinary thing is that even at this late date there seems to have been no explanation or symbolism attaching to the various methods of "advancing", and this leads to the conclusion that any interpretation offered on this point nowadays is a comparatively modern introduction". The three steps are symbolically explained as follows:—

"What do they morally teach us?"

"Upright lives and well squared intentions".

"None of the early records explain the symbolism of the steps ... We work that out for ourselves ... "

## From R.W. Bro. John G. Place, P.D.D.G.M. Nanton Lodge No. 17

I refer you to the Ancient York Ritual the second section of the First Lecture.

Also the Encyclopedia of Freemasonry and Kindred Sciences by Albert G. Mackey, published by the Masonic History Society, Chicago, page 433

"By the left side which is to indicate that the left side is the weaker part of the body and the Entered Apprentice is the weaker side of Masonry. Hence the left foot, the left knee, etc."



With reference to Vol. 39, No. 7, last page "Why is the first step in Freemasonry taken with the Left Foot" please be advised that the following is given by "Masonry Defined" by Lippincott-Johnston Article 117 —

"Left Side. In the symbolism of Masonry, the first degree is represented by the left side, which is to indicate that as the left is the weaker part of the body, so is the Entered Apprentice's degree the weakest part of Masonry. This doctrine, that the left is the weaker side of the body, is very ancient. Plato says it arises from the fact that the right is more used; but Aristotle contends that the organs of the right are by nature more powerful than those of the left."

The practice of the principles of Masonic brother-hood is the most important aspect of Freemasonry, said Most Worshipful Brother Gordon Armstrong, Grand Master of the Grand Lodge of Alberta when he visited Buffalo Park Lodge No. 44, at Wainwright recently. He also described as appropriate the study of the ritual and work of the Lodge, and the gaining of an insight into Masonic

history. He commended the local brethren on the work they were doing for the order in the community, and had some good words for the manner in which they performed the ceremonies of the third degree. He issued a warning against a clandestine publication which was being promoted by a group in the United States. He was welcomed to the East by Wor. Bro. Dave Rattray, W. Master of Buffalo Park.
