The Seventieth Annual Communication of the Grand Lodge of Alberta, Ancient Free and Accepted Masons, will be held at the Calgary Inn, Calgary, Alberta, Friday and Saturday, June 20th and 21st, 1975.

THE FREEMASON - A PILLAR IN SOCIETY

an address given by R.W. Bro. Hedley Parsons D.D.G.M. of District No. 4 at the District Meeting

I would like first of all to reflect back on every-body's entry into Freemasonry. At our Initiation we are given a number of beautiful lectures based on the fundamentals of our order, and in the J.Ws. lecture (Canadian Rite) we are directed as to the form and magnitude of the Lodge, and why they were so shaped and situated etc. We are also told that our institution is supported by three great pillars, which are wisdom, strength, and beauty. Because there should be wisdom to contrive, strength to support, and beauty to adorn all great and worthwhile undertakings.

A Pillar according to the dictionary is a column to support a structure, an upright support for a roof etc. Therefore in my opinion every Mason must strive to be a Pillar or if you like a monument in society. Individually strong and steadfast, always giving support to the structure.

The true Mason knows that nowhere is he a monument, a landmark or a pillar in society than right in his own home and in the community, where his family and neighbours can follow his thoughts and actions. We must never cheapen Masonry no matter where we are by vulgar actions or unmasonic conduct. Let our minds always reflect to the Sacred Writings which we are charged to consider the unerring standard of truth and justice, and to regulate our actions by the divine precepts which is contained therein. Re: our duties to God, to our neighbour and to ourselves.

To be an outstanding pillar in society one must be a person of quality. I think that everyone's life is spent in pursuit of self fulfilment, but not everyone reaches his objective. The man who succeeds is a person who has realized in time that satisfaction does not arise merely from being good at something but also being a certain kind of person. "A person of quality". A person of quality realizes that there is something beyond success. It is excellence and excellence is not conferred by the greatness of the office one holds. But one who builds greatly and lastingly. One who builds "CHARACTER" . . . In this modern world of today everything is mass-produced but one thing that cannot be mass-produced is character; because that is a matter of personal identity. Character is a positive thing. It is not protected innocence, but practised virtue; it is not fear of vice but love of excellence.

Character is having an inner light and the courage to follow its dictates. As Shakespeare put it: "To thine ownself be true, and it must follow, as night the day, thou canst not then be false to any man."

The person of quality will take delight in Crafts-manship, whether he be building a bird-house or a highrise apartment. There are sound standards of Craftsmanship in every calling, and we must meet them no matter what our position may be. This of course requires a sense of value of things and again this is a personal thing; not to be measured by a yardstick common to all. To be a pillar in society one requires many things, but above all a person must have Quality, Courage, Self-discipline, Enthusiasm and Energy.

An important question to ask ourselves frequently is: What value are we to our friends in their bad times as well as in their good times? There are some things that money cannot buy: KINDNESS, THOUGHTFULNESS, COURTESY, CONSIDERATION, TOLERANCE, SHOWING APPRECIATION and GOOD NATURE. These are

individual practices. Give according to the opportunities one can make. The pillar in society seeks all those opportunities and acts accordingly.

At our initiation we are told from the North East angle of the Lodge; that a Masonic Lodge is vast, universal, with branches spread over the four divisions of the globe. We are also reminded that there are many members of rank and affluence among our numbers. We are further reminded in the First Degree charge that Monarchs themselves have been promoters of our art, have patronized our mysteries and joined our assemblies. What greater Pillars in society could we ask for more than the Monarchs of our nation. Queen Elizabeth's Father King George VI was a Mason, her Husband Prince Phillip, the Duke of Edinburgh was raised in Navy Lodge No. 2612, London, England. H.R.H., the Duke of Kent is Grand Master of the Grand Lodge of England. Yes and there are many others: the late Bro. Sir Winston Churchill was a stalwart leader and a Freemason. English Naval Officer, Bro. Robert Falcon Scott, I am told, was the very first Mason to set foot on the South Pole.

Coming back to this Continent we have such Pillars in society as George Washington, Benjamin Franklin, F. D. Roosevelt, Harry Truman just to name a few of the Presidents in the past. The President of the United States at the present time, Bro. Gerald R. Ford is a 33 Degree Mason and very prominent in his role as such.

In the Theatre we have Pillars like Bro. John Wayne, the Hollywood cowboy. We have our own Brothers Frank Shuster and Johnny Wayne and others too numerous to mention.

In politics in Canada most of the Protestant Prime Ministers have been Masons and indeed Pillars in society ... MacDonald, Abbott, Bowell, Bennett, Bordon, Diefenbaker ... Illustrious Bro. Diefenbaker came up to Masonry via DeMolay likewise did Tommy Douglas join Masonry after being in the Order of DeMolay.

The late Charles A. Lindberg, I understand, wore the Square and Compass on his jacket as a good luck emblem on his famous Atlantic Flight in 1927. He was a Mason at the time.

American Astronauts: Edwin Aldrin, Virgil Grissom, Wally Schirra, Edgar Mitchall, Paul Weitz were all Masons. Gordon Cooper Jr. on his twenty second orbit flight around the earth carried a masonic coin and a blue Masonic flag in his pocket.

Napoleon was a Mason and according to information his Masonic Apron is still on display in a Museum in France. The list could go on and on:

Ontario's Premier, Bro. Wm. G. Davis is a member; Alberta's Premier, Peter Lougheed is a member of Perfection Lodge. We also have Pillars like Gordon Towers, M.P. and P.G.M. of the Grand Lodge of Alberta. All the P.G.M.s of this Grand Lodge and our present Grand Master were and are Pillars in society.

If a person is to walk with head held high, he must make his contribution to life. If he is to fulfil his destiny, he must leave the world a little richer and better than it would have been had he not lived and performed his services.

As Masons and Pillars we must be that supporting column or mainstay of Society, and according to the Grand Master's THEME be: Freemasons and Pillars in Society.

IN MEMORIAM

The Grand Lodge of Manitoba has announced the passing of M.W. Bro. Stanley Harrison Fahrni, Grand Master, the Grand Lodge of Manitoba in 1942 and of M.W. Bro. Thomas Cyril Jackson, Grand Secretary of the Grand Lodge of Manitoba from 1951 to 1972. He was made an Honorary Past Grand Master of that Grand Lodge in 1954. Both of these distinguished Masons were

Honorary Past Grand Masters of the Grand Lodge of Alberta. Bro. Fahrni was presented with this honour in 1942 and Bro. Jackson in 1954. Bro. Jackson is well known throughout this Jurisdiction for he was a very frequent visitor to our Grand Lodge Communications. The brethren in Alberta join their brethren in Manitoba in paying respect to the memory of two Past Grand Masters.

CALGARY ALBERTA LODGE "FIRST"

In the history of any Lodge, it is a noteworthy event to have a Brother elected to serve a term as District Deputy Grand Master. In the current Masonic Year, a landmark event came to pass when no less than three Brethren raised in King George Lodge No. 59 G.R.A., Calgary, Alberta were installed as District Deputies in three Alberta Masonic Districts on June 22, 1974.

On the evening of November 22, 1974, King George conferred the M.M. degree on five Brethren at their annual Past Master's Night. The occasion was selected by these three District Deputies, in co-operation with R.W. Bro. H. J. Miller (DDGM District 18), as a suitable occasion to pay a surprise joint visit to King George Lodge. Along with the currently serving DDGM's of Districts 1, 6, 12 and 18; R.W. Bro. R. L. Costigan (Grand Treasurer); R.W. Bro. C. Bloomfield (Grand Tyler); R.W. Bro. R. Maxwell and R.W. Bro. J. A. Bailey (both PDDGM's District 18), were also in attendance, along with a large number of King George members and visitors.

R.W. Bro. George S. Poulter (District No. 1) was raised in King George in 1958, became a Charter member of Bowmont Lodge No. 181 G.R.A. in 1960, and served as Master of that Lodge in 1970. R.W. Bro. Brian E. Smith (District No. 6) was raised in King George in 1958, became a Charter member of Glenbow Lodge No. 184 in 1961, served as Master of that Lodge in 1967, and has been Secretary of that Lodge since 1971.
