

M.W. BRO. ANTON OSCAR ASPESLET

Anton Oscar (Tony) Aspeslet was born in Surrey, England, on July 1st, 1918. Coming to Canada before he was a year old, the family settled in Bruderheim, Alberta, where he attended Public and High School.

In 1941, he enlisted in the Canadian Army and served in Canada and U.K., with the South Alberta Regiment. He continued serving in the Canadian Army Militia until 1967, retiring after commanding the 18th Field Artillery Regiment for five years.

In 1951, M.W. Bro. Aspeslet joined the Dairy Division, Alberta Department of Agriculture.

He was initiated, passed, and raised in Charity Lodge No. 67, in 1958. He became the Worshipful Master of Charity Lodge in 1964, and 1970. In 1971-1972 he was District Deputy Grand Master of District No. 7.

After serving Grand Lodge for a number of years on a variety of Committees, he was elected Junior Grand Warden at the Grand Lodge Communication, 1973. In June of this year, he was elected and installed as Grand Master of Masons in Alberta.

M.W. Bro. Aspeslet married Iris Newnham in July, 1943. They have one son, married with four daughters.

He is a member of St. Augustine's Anglican Church in Lethbridge, and served on Vestry and as sidesman.

A MESSAGE FROM THE GRAND MASTER

Brethren, I wish to take this opportunity in this the first Bulletin of the new Masonic season, to express my sincere thanks to the Masons of Alberta, for having conferred on me the high office of Grand Master. I deem it a very great honor. I am also aware, that it imposes on me important duties and responsibilities. I pledge to attempt to carry out those responsibilities to the best of my ability, and I trust that my efforts will meet with your approval.

During the past three years, while progressing through the offices of Warden and D.G.M., I have often been reminded of the feelings one has in passing through the three Craft degrees. When one enters Masonry it is like entering a new life; the novice does not know what to expect and is untrained. However, as he progresses, hopefully, he learns and acquires new skills. Secondly, one enters Masonry of his own free will and accord, similarly, whatever else one does during his Masonic career is also of his own choosing. We must not forget, however, that in accepting the honours and privileges that Masonry has to offer; we at the same time, assumed important duties and heavy responsibilities. As we progress in the Fraternity those duties become greater.

As my theme this year, I have chosen, "RE-SPONSIBILITY". It is my hope that this theme will cause us to think and create discussion. In this way each one of us may be able to obtain a clearer idea of just what our responsibilities are as members of the Craft.

You will no doubt recall that great charge to the E.A. This charge informs us in many ways just what those responsibilities are. It informs us, in the first instance, to regulate our lives and actions by the Divine Precepts contained in the V.O.T.S.L. That therein, we will be taught the duties we owe to God, to our neighbor and to ourselves. This charge then goes on and describes the obligations we have as citizens, as individuals, and as Masons. Finally it calls on us to make a daily advancement in Masoniç knowledge. As custodians of the ancient landmarks, customs and usages, it behooves us to make a study of the plans on the tracing board, learn the uses of the tools of our trade, and apply them, diligently in our daily tasks.

It is also our duty as Masons to take the rude material that comes to us in the guise of the newly initiated brother and mold and shape it to the Masonic pattern. This will require of us time and effort. This operation has a two fold benefit, for we not only dispense instruction to others but we widen our own sphere of knowledge in the process.

We urge our initiates to make a daily advancement in Masonic knowledge. We make them custodians of our ancient customs and landmarks, but we seldom take the trouble to explain the plans and designs, or instruct them in the use of the tools. Brethren, they need our assistance, and it is our responsibility to provide that assistance.

We have a responsibility to the man we call brother. Do we just recognize him in the Lodge room and pass him on the street. Can he be assured that his appeal for assistance or advice will be answered.

We have a responsibility to our Lodge. We ought to attend regularly, pay our dues promptly, we should carry out our duties to make our Lodge a live organization that will radiate Masonic Fellowship. This cannot be done by remote control, each of us must be on the job when the gavel sounds.

We have a responsibility to the whole Craft. The profane do not judge Masonry by what they read of its tenets and philosophy, they size it up by what they see in its members. If we are to sell our philosophy to good men and true, our actions in our daily lives must be convincing.

A TOAST TO THE GRAND MASTER AND HIS OFFICERS

The traditional and correct toast to the Grand Master and his Officers is a courtesy at every Masonic hour of refreshment. It is replied to by a representative of the Grand Master. The reply is often trite and unprepared. Recently we were impressed by a thoughtful reply to the toast given by R.W. Bro. R. J. L. Borland now P.D.D.G.M. for District No. 6. We requested a copy of the reply and now print it below;—

Thank you for your kind toast to the Grand Master and to his Officers. As the ranking incumbent present, I am pleased to be able to reply to the toast, although my representation of the Grand Master may not sit lightly today (sorry that's an inside story).

Grand Lodge is, as you are all well aware, made up of elected and appointed officers who have the care and custody of the Craft during their term. They of course must answer to the Board of General purposes who are your watchdogs between sessions of the Grand Lodge itself.

This Board has power to dictate to any Lodge or any Officer of Grand Lodge in order to preserve the Constitution that you have legislated. Even Grand Masters must stay within the limits of the Constitution and are therefore answerable to the Board of General Purposes for their actions.

DOMINION LODGE NO. 117



We apologize for missing the presentation of a Fifty Year Jewel to the late W. Bro. D. Ross by M.W. Bro. P. Kendall, P.G.M. at a ceremony in St. Joseph's Hospital in Edmonton last spring. W. Bro. Ross was 92 years of age. Present at the event was V.W. Bro. James Hoyle, the first candidate raised by Bro. Ross. The Masonic History of the Ross family goes back to the initiation of Donald Ross Sr. in Saskatchewan Lodge No. 17, G.R.M., in 1883 and he became its Worshipful Master in 1886. The present Secretary of Dominion Lodge No. 117, W. Bro. D. G. Ross was initiated in 1956 and was its Worshipful Master in 1964. This very distinguished Masonic Family has a history of 92 years membership in the Craft, certainly a record of which it can be very proud.
