# DUTIES AND RESPONSIBILITIES OF LODGE OFFICERS (Continued from March Bulletin)

In this issue of the Bulletin the duties and responsibilities of the office of the Junior Warden, Senior Warden and Worshipful Master will be discussed.

Junior Warden

This officer is expected to become familiar with the duties and responsibilities of the Worshipful Master and the Senior Warden as well as those of his present office. He will rule the Lodge in the absence of the Worshipful Master and the Senior Warden. He is the Social Convener of the and chairman of the Festive He is also in charge of the refresh-Committee. ment periods and has a great opportunity to show his mettle as a Mason by introducing new, constructive ideas into this important function of the Lodge. He should help the membership get to know other Brethren, devote some time to visitors and introduce some instructional programs. He should have a purpose and expand upon it at each meeting He must learn protocol and be prepared to deal severely with those Brethren who seem to think that the refreshment period is the place to show tell off-coloured stories. their ability to There is no room in Masonry for vulgarisms and they distresses many Brethren. It is the duty of the Junior Warden to attend the Grand Lodge District Meetings and other Communication, Masonic meetings including the Banff Spring Workshop. He should visit other Lodges within his district and exchange ideas with other Junior This officer must also be aware of costs as far as Lodge social functions are concerned but should not be too cheap. function is worth having, it must be dignified and therefore the membership must be prepared to support it at a reasonable cost.

#### Senior Warden

In the absence of the Worshipful Master he will rule the Lodge from the chair North of the W.M.'s chair. He is expected to prepare for the event of being elected as Worshipful Master by becoming familiar with the Constitution and the By-Laws of the Lodge. He is also expected to know the ritual backwards and forwards. As Senior Warden he should assist the Worshipful Master before Lodge is opened by greeting visitors and, where necessary, arrange for Boards of Trial. It is his specific duty as Senior Warden to satisfy himself that all attending each meeting are, in fact, Masons in good standing and determine their rank as E.A., F.C. or M.M.'s. As a principal officer of his Lodge he is obligated to attend the Annual communication of Grand Lodge as well as the Annual District meeting. His attendance at the Banff Spring Workshop and at the Education

and Research Committee meetings will prove most worthwhile and assist him in subsequent years. He is Vice President of the Lodge and must communicate with the W.M., the Junior Warden and the Secretary at all times and keep himself informed as to what is going on at all times. During this year he should be developing a plan for the next year and be ready to act at a moments notice should a situation develop where he must step into the shoes of the Worshipful Master because of sickness or some other unforeseen problem which keeps the W.M. from attending Lodge.

The Senior Warden, in some Lodges, is responsible for the safe and proper keeping and repair of the Lodge jewels, furniture and paraphernalia. He is also responsible for maintaining a complete inventory of all Lodge property. For the good of the Lodge he should ensure that all Candidates are receiving proper instruction and are ready to prove their proficiency in the previous degree. This officer should visit other lodges regularly to meet other Senior Wardens so he will know his peers when he is elected to be Master of his Lodge.

Worshipful Master

His specific duty is to see that the affairs of the Lodge are conducted in strict conformity with the most current Laws, Regulations and Edicts of Grand Lodge. It is his duty to ensure the Lodge is represented at the Annual Communication of Grand Lodge and the Annual District Meeting. As a Worshipful Master he is expected to be able to open and close Lodge, confer the degrees, conduct the business meetings properly, arrange for regular programs of Masonic education, receive visitors and Grand Lodge Officers graciously and with proper form, understand and practice Masonic protocol, rule his Lodge firmly but with understanding and finally, start each meeting on time.

A good worshipful Master will have back-up people for each office and for each degree part in case of a last minute problem. He will see to it that everyone knows his individual responsibilities and carries them out with dispatch and dignity. He is the president of the organization and fully responsible for everything it does. This office demands all of his time and thought if he is to be successful.

The next issue of the Bulletin will see the end of this series with a discussion of the duties and responsibilities of Past Masters and of sponsors.

## MOTIONS TO BE PRESENTED AT GRAND LODGE JUNE 13 AND 14, 1986 GRANDE PRAIRIE

1986 should be a must interesting year for the brethren attending Grand Lodge as the number of notices of motion to be presented is exceptionally large. Normally an attempt is made to publish these in the Bulletin but the amount of material makes this impossible. It is vitally important that the representatives of your Lodge express the views of the Lodge at the Annual Communication but this can only be achieved by discussion of the motions in your Lodge.

It is my intention to summarize the motions in a neutral way to allow you to identify those where you have strong feelings and allow you to then follow them up by reading and discussing the full version in your lodge with the committees appointed by direction of the Grand Master.

Please note, explanations are printed on the full version which is with your Lodge Secretary.

# MOTIONS

- To hold the 1989 Communication in Medicine Hat.
- To change the Burial Service to make it suitable for cremations also.
- 3. To use the canvas in the Canadian Rite.
- To use the S of F when adjusting the V.O.S.L. (Canadian Rite).

## PROPOSED AMENDMENTS TO CONSTITUTION

- 579 To send a double registered letter informing of possible suspension for NPD 620(1) & (2) suspension and dual membership. 541 checking of Affiliation petitions with Grand Lodge.
- 2. 573(1) To vote on Honorary Life Membership BEFORE asking consent of recipient. 573(2) To require a two thirds majority vote to give Honorary Life Membership to a Mason, NOT a member of the Lodge
- 82: Per capita fee to be \$15.00 per annum. Effective 1986.
- 4. 9: Change time of Annual Communication commencement to no earlier than 8:00 a.m. to meet special needs.
- 730(6) To create a long service jewel for organists.
- 719(4) To create a Grand Lodge Apron for the Grand Chaplain or Organist who is NOT a Past Master.
- 208 To change the voting method for DDGM's at District Meetings.
- 48: 1007 To have research lodges report to the D.G.M.

# COMMITTEE MOTIONS AND PROPOSALS FOR AMENDMENTS TO CONSTITUTION

 To establish the membership format and duties of the Jurisprudence Committee.

To allow special Committees and the Jurisprudence Committee to propose constitutional changes directly to the annual Communication.

2. To change the trial system by removing the review committee and the system for automatic appeal. To include appeal by the person convicted or the prosecutor. In the case of no appeal, to have the Jurisprudence Committee review the trial for fairness.

To clarify the effect of expulsion or suspension on those holding office.

To establish the financial year of Grand Lodge as January 1st to December 31st.

To appoint an auditor.

To establish an administration fee for the Relief Fund. (2%)

 To change the structure of the Board of General Purposes the principal decision making body of the Jurisdiction.

The changes proposed are:

- to change the membership by having not only D.D.G.M.'s but also an elected member from each District. The D.D.G.M. and the elected District Representative to be elected by Master Masons and P.M.'s in the Districts.
- to limit the term of office of P.G.M.'s to five years on Board.
- to institute the positions of Senior and Junior District Wardens to be elected in the District. Their role will be to assist the D.D.G.M. and progress, if satisfactory, to the position of D.D.G.M. these officers not to have Grand Rank.
- to have the Grand Master consider all elected officers for confirmation.
- to have a candidate for D.D.G.M. to have served as a District Warden for at least one year.
- to have the District Representative liase between the Board of General Purposes and the Lodges in the District.
- to establish a Mechanism for Nominations and elections.
- to clarify the role of the D.D.G.M.
- to establish of the role of the Wardens and the District Representative.
- to institute a Grand Advisory Council consisting of all past Grand Masters to deliberate, recommend and advise on matters referred to it by the Board and/or the Grand Master, or on matters considered of concern by its membership.

# ANSWER TO THE FEBRUARY QUESTION OF THE MONTH

Q: Who is expected to attend from each Lodge at the Grand Communication?

A: The Master and the two Wardens.

Firstly the Master has made sworn obligation to attend all communications and committees of the Grand Lodge when notified of the same. This is number twelve of the Ancient Charges to which the UNQUALIFIED ASSENT of the Master elect was required and given in open Lodge.

Secondly, the two wardens are members of Grand Lodge and have equality with all other members (Constitution Part 1, Section 5). They are expected to vote (Section 20) but if absent their vote is CLAIMED by the most senior of the three officers present. They with the Worshipful Master are most current in Lodge affairs. In addition to the above noted officers, all Past Masters are voting members of Grand Lodge and it is desirable that they attend.

## ANNUAL COMMUNICATION 1986

RULES OF ORDER as authorized by

M.W.Bro. W.C. Graves, Grand Master

As our Grand Lodge defines only the Rules of Order as laid down in Sections 29 to 32 and leaves all other Rules of Order to the discretion of the Grand Master, he has determined that the following shall be the General Rules of Order for the conduct of the Eighty-first Annual Communication with the understanding that, should any question of order arise, the Grand Master shall have final and definitive say as to its disposition.

- 1. The Rules of Order as contained within Section 29 to 32 of the Constitution shall be strictly adhered to. Any other Rule of Order which can be verified within the Constitution shall take precedence over any Rule of Order listed below
- 2. The Grand Master shall reserve the right to limit the time allowed for any brother to discuss any question.
- 3. Should the mover of any motion wish to speak a second time on the motion, other than to answer a question, the Grand Master shall advise him that such action will end debate and ensure that all brethren have been fairly heard first.
- 4. Any brother wishing to speak to a question shall rise, approach the nearest microphone and wait until he is recognized by the Chair before proceeding to speak. The Grand Master shall determine who is entitled to the floor. Once recognized the speaker shall give his rank, name and Lodge No. before addressing the meeting.
- 5. A 'Motion to Table' any item shall be debatable and shall require a two thirds majority vote to pass. Any 'Motion to Table' must include directions as to the disposition of the item or motion under discussion and a time limitation for such disposition.
- 6. Amendments to any Notice of Motion must be given; in writing with the mover's and seconder's name, rank and Lodge; to the Grand Secretary immediately following their presentation. Only two amendments will be allowed to any motion.
- 7. The Grand Pursuivant and the Grand Tyler shall ensure that no member enters or leaves the meeting during the taking of any vote on the floor.
- 8. No more than one motion shall be put to the floor at any time except in the case of Amendments or 'Motions to Table'.
- The Grand Master shall be entitled to debate on all subjects, on requesting the Deputy Grand Master to assume the chair.
