GRAND MASTER 1986/87

Most Worshipful Brother Norman Frederick Oslund was born in Ryley, Alberta on June 17th, 1925. He was initiated in Astra Lodge No. 179 in 1961 and demitted in 1971. He affiliated with Palestine Lodge No. 46 in 1968 and was W.M. in 1970/71, 78/79, and 79/80. He also affiliated with Avon Glen Lodge No. 170 in 1980. M.W.Bro. Oslund was D.D.G.M. of District No. 20 in 1981/82 and was elected Senior Grand Warden in 1984. He demitted from Avon Glen No. 170 in 1985, to affiliate with Astra Lodge No. 179 in the same year. M.W.Bro. Oslund served overseas with the Canadian Army (W.W.II), R.C.A.F to 1968 and was awarded the Canadian Forces Decoration.

He has been the Chief Executive Officer, of the Canadian Corps of Commissionaires, for Northern Alberta from 1970 to the present.

M.W.Bro. Oslund married Marjorie Sutton in 1944.

M.W. Bro. Oslund is active in all Concordant Bodies - York Rite, Scottish Rite and Al Azhar Shrine Temple, and is an associate member of Al Shamal Temple.

THE MOTIONS AND RESOLUTIONS CONSIDERED AT THE 1986 GRAND COMMUNICATION

RESOLUTIONS

- 1. The resolution to hold the Annual Communication in Medicine Hat in 1989 was approved.
- 2. The changes proposed to the Burial Service were referred to the Committee on the Work.
- i) The resolution to use the canvas in Canadian Rite Lodges was NOT approved.
 - ii) The resolution to use the Sign of Fidelity when adjusting the altar lights was referred to the Committee on the Work.

MOTIONS TO AMEND THE CONSTITUTION

- The series of motions related to suspension, warning of impending suspension, dual membership and affiliation were all defeated.
- The motions relating to Honorary Life Membership were approved and the brother's consent must be obtained AFTER a favourable vote of a 2/3 majority.
- It was approved that the per capita fee shall be \$15.00 per annum from January 1st, 1986.
- 4. It was approved that the Annual Communication may be announced to commence any time after 8:00 a.m. on the usual dates, to allow for the volume of business.
- It was approved that organists may receive a long service jewel.
- 6. It was approved that a Grand Organist or Grand Chaplain who is not a Past Master may wear a special apron while in office and should he later become a Past Master, he will automatically be entitled to the rank of Very Worshipful Brother.
- 7. It was approved that a) at a District Meeting, the D.D.G.M. will only obtain a extra vote if the number of votes to be cast is evenly divisible by the number of candidates b) a run-off ballot will be held to break low vote ties if no candidate receives over 50% c) the eligible voters list is to be corrected if any voter leaves before balloting is complete.
- 8. It was approved that the Deputy Grand Master shall act in the capacity of a D.D.G.M. to Fiat Lux Lodge of Research.
- a) The new structure and duties of the Jurisprudence Committee were approved and it was removed from the list of Standing Committees.
- b) Special Committees and the Jurisprudence Committee may now recommend amendments to the constitution through the normal process of publication and presentation at the Grand

Lodge Communication but without the need to have a Lodge make the Notice of Motion for the Committee. $\,$

- The changes to the Masonic Trial System were approved.
- 11 a) An auditor was appointed and b) The year end date was changed from April to December 31st. c) The normal administration costs of the Relief Fund would be transferred to the General Fund at the year end established in 11(b).
- 12. The proposed Notice of Motion to alter the structure of the Board of General Purpose was tabled for one year with input from the Lodges being sought over this period.

QUESTION OF THE MONTH

Is it necessary for a brother to reside in the area of a Lodge in which he wishes to petition for affiliation?

ANSWERS TO THE QUESTION OF THE MONTH

The Question of the month for April asked:

'Where is the letter 'G' in a Lodge room, other than attached to a ceiling, wall, or furniture.'

Master Mason aprons have a 'G' on the buttons which means that the Lodge in action has the 'G' on almost all sides.

The Question of the Month for May asked:

'a) What is a sitting Master?'

The answer is quite simple in that there is no such person and the term should never be used. If one is talking about those who are in office at that moment, the term Worshipful Master identifies them precisely. A Past Master is not a Worshipful Master and cannot respond in error.

'b) should the principal officer of a lodge be referred to as Worshipful Brother.'

This answer is contraversial but the Worshipful Master should be accurately referred to as "Bro. Worshipful Master", or simply "Worshipful Master". The ritual never refers to the Worshipful Master in any other way. The term Worshipful Brother is assumed when one has left the chair of Worshipful Master.

DUTIES AND RESPONSIBILITIES OF LODGE OFFICERS

In this issue the duties and responsibilities of Past Masters will be discussed. The final article next month will deal with Sponsors.

A Past Master is a Brother who, for a period of at least one year, has presided over his Brethren as Master of his Lodge. At the end of this time he was replaced by a new Master, as capable as he was, with new ideas, new vigour and sometimes a new direction for the Lodge. A Past Master is a member of the Board of Installed Masters essential to place the new Master into the chair of King Soloman. He may be elected to be part of the Examining Board which ensures that the new Master has the ability to run the Lodge and can perform the degrees necessary for bringing new members into the Lodge. He may be asked to act on the Investigating Committee to ensure that visitors are masons and entitled to attend the Lodge. Another duty he should be prepared for is to act as the Installing Officer at the installation of the Lodge whether it is as a routine matter or for a special Brother. He should also be ready, if he is asked, to raise a Brother for some special reason or as a family matter or to give the Obligation for similiar reasons, - which latter task only a Past Master or the Master may do.

Because of his knowledge and experience, a Past Master should be prepared to help his Lodge and contribute to its success by taking the office of Secretary, Treasurer, Director of Ceremonies or Tyler. These offices, in most Lodges, are not in the normal chain of progression therefore a Past Master can provide a most useful service to his Lodge and allow younger members to pass through the chairs to gain their own experiences. Occasionally a Past Master may be asked to act as a fill-in, in the line of officers, to avoid too large a jump in the officers line if gaps occur. This should not be a permanent move into the progression of the line, but just a service for the maximum of one year duration. He may be asked, and he should be willing to serve, on any Lodge Committees where his experience can contribute to the life of the Lodge. He must always remember that he is a member of the committee and never try to take it over.

A Past Master is a member of Grand Lodge and it is his responsibility to attend each Grand Lodge Annual Communication and express his opinions on subjects discussed at the meetings. The same applies to the District meetings; he must be prepared to vote for the best candidate for the office of D.D.G.M. as well as for all other matters properly brought before the meeting.

His knowledge of the "work" and his experience makes him a valuable person to help coach a candidate. He should be a friend and mentor to all new Masons. When a past Master sees a face that he does not recognize, he should be the first to hold out his hand, introduce himself and make his new friend feel "at home". He should then introduce this Brother to other Masons present and

thus establish the bond of fraternal caring that must be dominant in our Masonic lives.

There is a long list of other activities and involvements for the Past Master but perhaps this article has given enough to set brethren thinking that "Past" does not mean "through", but really means "equipped for real activity beyond and within the Lodge". A Past Master should never abandon his Lodge as it has been his "base" of learning for the wonderful lessons of the fraternity. He should keep involved but remember that the reins of leadership have been passed on to another expert craftsman who has the same ideals, same enthusiasm, same energy as he had and will make the same mistakes - let him, and he will join the Past Masters' ranks as an experienced - tested Brother who has enlarged his knowledge and skills because, he too has been involved.
