PROCLAMATION

FOLLOWING THE GOOD TRADITION SET IN OUR JURISDICTION, I HAVE PROCLAIMED NOVEMBER AS "HIGHER EDUCATION BURSARY" MONTH. I AM REQUESTING THAT DURING THE MONTH ALL MASONS IN THIS JURISDICTION MAKE CONTRIBUTIONS TO THIS FUND. EVERY BROTHER SHOULD GIVE AS HIS CIRCUMSTANCES WILL PERMIT. SOME WILL BE ABLE TO GIVE MORE THAN OTHERS BUT WE SHOULD ALL EXERCISE THAT GREAT ATTRIBUTE "CHARITY" AND "OUR GUIDE FOR LIVING" TO THOSE IN NEED. LAST YEAR WE GAVE OUT \$54,000.00 IN BURSARIES, WHICH INCLUDED BEQUESTS. THIS YEAR WE WERE ONLY ABLE TO GIVE \$42,000.00. A LITTLE ARITHMETIC SHOWS WHAT WE NEED FROM OUR 13,500 OR SO MASONS IN ALBERTA. THERE IS A NEED FOR THESE BURSARIES AND THE MONEY COLLECTED IS EFFECTIVELY USED. THE SUCCESS RATE OF STUDENTS ASSISTED HAS BEEN EXCELLENT SO LET US KEEP UP THE GOOD WORK AND IMPROVE OUR EFFORTS THIS YEAR.

The Most Worshipful Grand Master of the Grand Lodge of Alberta, Most Worshipful Brother Norman F. Oslund has proclaimed October 1986 Masonic Higher Education Bursary Month and requests all Masons in the jurisdiction to donate to this most worthy cause, which was initiated to help needy students of Alberta to attend secondary education.

Bursary month has been advanced to October this year for two reasons. One is that the Masonic year now ends on December 31, and second, to move a little further away from the Installation and Festive Season.

Those members who donated to the Fund this past year are to be congratulated for donations of \$42,094.18 which was an increase of approximately \$7,000.00 over last year. This will enable us to give approximately 48 students bursaries of \$900.00 to help with their education. However, we do not have sufficient funds to support the many other students who require assistance.

Each year the cost of education rises; first year university fees are now approximately \$1,200.00. If we were to give each student tuition fees, we would only be able to assist 37 students. This is why we desperately need your donation to help the Bursary Committee in meeting the ever increasing demand for assistance.

Brethren, I quote from the Report on the Condition of Masonry as presented by Most Worshipful Brothers W.A. Milligan and N.F. Oslund, "It is worthy to note that approximately 68 Lodge did not contribute to the Higher Education Bursary Fund in 1985-86. We as Masons owe it to those who had the foresight of recognizing the need for such a fund to assist those in need regardless of Race, colour, or Religion and to show others that Mason care. We would like to suggest that not only District Deputy Grand Masters and Masters of Lodges, but all Masons talk this worthwhile philanthropy up and include it in their every day agenda and show the world the extended hand of Masonry."

Shortly, each member will receive a pamphlet on the rules, regulations and operation of the Fund. It is hoped that more knowledge will spark more interest among the membership. It is felt that in the past many members did not know enough about the Fund and therefore were reluctant to give. It is also noted that in some districts there is a Challenge cup for the Lodge with the highest per capita donation. It has also been noted some District Deputies pit their District against another. The Fund appreciates any effort that encourages donations to the Fund.

Each year the per capita ratio increases. We are now at about \$2.35 per member. The assistance we supply gives a good reflection on the Craft in the eyes of the general public. But, "how many of our members are free riding on the efforts of others"? In the past, this figure was 90%. This year 86% are not giving support. How about you, are you a giver or a free rider? To all those who have supported the Fund in the past "Thank-you" and please keep up your much needed and worthy support.

In conclusion Brethren I would like to leave you with a thought. Each and every one of us have been asked that age-old question, would you give if it was in your power to do so and every time it has been answered with an emphatic "Yes". Now is the time for us all to put this into practice. You are now being asked to give to a most worthy cause, the Masonic Higher Education Bursary Fund. Please do not fail to give that emphatic "Yes", and send in you donation now.

DUTIES AND RESPONSIBILITIES OF LODGE OFFICERS

In this issue of the Bulletin, the duties and responsibilities of Sponsors will be discussed. This is the final article of the series.

These people are not always officers of a Lodge but they do have serious responsibilities. When a cowan shows an interest in becoming a member of our Craft it is the responsibility of the member to make the prospective candidate aware of the kind of organization we are as well as what we are not. We are not a service club, an insurance society, a group who only deal with our own membership or extend benevolence internally. We are a fraternal organization that wishes to improve public and individual morality, provide an opportunity for men to meet and enjoy the pleasures of friendly companionship on the spirit of helpfulness and charity, guided by strict moral principles. The members are encouraged to practice a way of life that will sustain high standards in their relationships with their fellow men. In other words, the practice of Brotherhood. It is an organization which recognizes no distinction between races, creeds or social qualifications. The sponsor should supply the interested person with the brochure on the Craft obtainable through his Lodge Secretary.

When the prospective candidate states his readiness to join the Craft, the sponsor obtains from the Secretary of his Lodge the Grand Lodge letter as well as an application form, keeping in mind that the application form requires the signature of two sponsors who actually know the candidate personally. It is the sponsors responsibility to see that the candidate clearly understands and signs the Grand Lodge letter which permits the Craft to investigate the person wishing to join before having him complete the application form.

The sponsors must see that the candidate they have supported gets to Lodge on each occasion and while there, they should stay with him at all times except when he is under the control of a Deacon or other Lodge Officer. At the time of his initiation the sponsor must impress upon the candidate the solemnity of the ceremony and that there will be no horse-play of any kind whatsoever. A sponsor must be prepared to act as a coach and to explain the mode of preparation experienced by the candidate the meaning of certain phrases in the ritual work as well as the actual teachings of each degree. This is not an easy task and requires a great deal of thought and effort on the part of the sponsors. The "Little Brown Book" may help any sponsor in his explanations.

In order to maintain the interest of a newly raised member the sponsors should advise him of "work" he could do and help him learn it. The sponsors should encourage the new member to visit other Lodges and accompany him on such visitations. The sponsors should guide and help educate a candidate and new member for at least a year in order to stimulate his interest and get him into the habit of attending Lodge on a regular basis. The responsibilities and duties of a sponsor are many and onerous but can improve the future of our Craft if properly attended to. If anyone signs a membership application form as a sponsor he must be prepared to follow through and fulfill the duties and responsibilities expected of him.

CELEBRATION YEAR

The Centenary of the Premier Research Lodge of the World, Quatuor Coronati Lodge NO. 2076 occurs in 1986. The Centenary Celebration meeting was held at Great Queen Street in Freemasons' Hall on May 8th, 1986. We congratulate the Worshipful Master and members of "Q.C.", as it is affectionately called, on their past successes and their future endeavors. Alberta Masons wishing to become corresponding members should contact one of the Alberta membership chairman. M.W. Bro. A.O. Aspeslet looks after the South while R.W.Bro. R.C.T. Hayes deals with the North.

Another successful Klondyke Lodge was held in Edmonton on July 23rd, 1986. This year the event was sponsored by Empire Lodge No. 63. ANSWER TO QUESTION OF THE MONTH

The question of the month for June asked where the Officer to be Immediate Past Master whould stand when the Officers are called onto the floor at the beginning of the Installation Ceremony.

First, as current W. Master he has the prerogative to install his successor and can hardly have himself called onto the floor. (p1) Second the elected or appointed officers are

called onto the floor and then the Master asks the Lodge to look at these "appointed and elected officers." (p3)

Third, the new Master, in addressing the IPM, states that the office of IPM is not in the power of the W.M. to bestow but is an earned right. We know he was not elected and the Master says he cannot appoint him. (p24)

The answer to the question is therefore: The IPM is not called onto the floor as he is neither elected nor appointed and his right to office cannot be challenged at this point in the Installation meeting.
