## GRAND MASTER'S QUESTIONNAIRE

The final question in this questionnaire is "What practical ways can be used to improve lodge meetings?"

There were two major themes in all the responses. The first was a serious concern over the lack of <u>quality</u> Masonic education available. Some expressed the opinion that education should not be restricted to purely Masonic topics if it was to be offered at the Festive Board. The second major point expressed related to <u>boredom</u>. It was considered to be a deterrent to good meetings and good attendance.

A third theme noted with less frequency than the others was the lack of good communication and the requirement that the notice contain more information and at an early date.

In order to reduce boredom there were many suggestions but the primary ones were: doing business in the 1st degree and dealing with the business through committees, thus leaving more time for education, degrees and socializing.

Some expressed concern over the fact that there was little or no attention paid to non-attenders. (One respondent said he was too embarrassed by his lack of proficiency after a twenty year absence from meetings to try to get back into his lodge!) There would seem to be a strong argument to seek out non-attenders and offer a non-threatening Lodge of Instruction to orient them back to their lodges.

#### Meetings:

A number of respondents blamed the Master for poor conduct of meetings, lack of program - either in Lodge or at the Festive Board, and failing to follow the Ritual and Constitution. Failure to start on time or suitably acknowledge visitors were also problems placed at the Master's feet.

There was a complaint about the length of some Grand Lodge letters and the need to specify the critical areas to be read out in lodge.

There was an opinion expressed by a few respondents that the ritual itself needed revision, allowing the work to be done in the first degree, and that the language should be updated. Some respondents felt that joint meetings should be emphasized to stimulate the lodges.

## Education:

There was a strong wish for total involvement in Education and more professional educators participating. Some felt that the education component could be non-Masonic topics. There were suggestions for District Education competitions and better use of audio-visual techniques, and exchange of programs between lodges. Some respondents want the District and Grand Lodge R & E Committees to take the lead with ideas.

## Other Improvements:

Effective phone and visitation committees were seen as vital to any lodge. The sponsors and investigations of candidates should be more involved with new members' progress, and attendance at a Craft lodge should be a requirement for membership in Concordant bodies.

Dinner meetings, functions which involve the whole family, work projects for widows or infirm brethren and work teams for lodge maintenance were all seen at activities to liven up a lodge.

The final section of the Questionnaire asked for "Comments" and many of these repeated the comments already reported in previous sections of the questionnaire.

Some comments recommended action which already is in operation or is not disallowed. This seems to point out the lack of education on basic issues within the Craft.

There were many specific ideas but communication within the Craft is noted regularly; the need for less repetition, more music, more involvement, better image and some leadership training are all points raised. There is concern about widows, distressed brethren, nonattenders and family involvement which must be addressed at the local level.

## EXCERPT FROM SOCIETY AND THE MASON'S MORAL LEADERSHIP by V.W.Bro. J. Roberts

When we enter the Lodge we bring with us some of the baggage that has been laid on us by the world. While we are in the Lodge we leave it just outside the door, but we pick it up again as soon as we leave the "sacred retreat". And though we have been counselled ever so clearly to go out into that world with higher and better resolves, I wonder how many of us - and I include myself take with us the working tools of the speculative Mason. If we leave the working tools safely in their box, then of what value are they?

I wonder if it's not only "the secrets of Masonry we lock up in the safe and sacred repository of our hearts" - but the meaning of the square and compasses as well. Oh yes, we are counselled to take our precious teachings with us into the world. My question is, "how well do we undertake that counsel and apply it"?

#### FROM AFAR

The United Grand Lodge of England in its December 1988 letter to the Craft warned of the commercial misuse of Freemasonry. The particular case, to be discussed by the Board of G.P., was an attempt to associate Freemasonry with an item of non-Masonic merchandise. The letter warns brethren to avoid attempts to promote sales using Masonic symbols on items with no Masonic relevance.

In the Quarterly Communication of the Grand Lodge of England for September 1988 the following item is of importance to Canadian brethren who may visit Britain. "Only Brethren who are members of Lodges under recognized jurisdictions may visit English Lodges. They must produce a certificate (i.e. a Grand Lodge Certificate or other documentary proof of Masonic identify provided by their Grand Lodge); should be prepared to acknowledge that a personal belief in T.G.A.O.T.U. is an essential Landmark of Freemasonry, and should be able to produce evidence of their good standing in their Lodges."

Editor's Note: The documentary proof can be a letter from a Grand Secretary (which is common procedure for British Masons to follow when visiting overseas) as many have no "dues card".

# **GRAND LODGE OF ALBERTA FINANCE COMMITTEE**

This committee is a standing committee of the Board of General Purposes, and acts under the powers contained in the Constitution of the Grand Lodge, mainly Part III - Boards and Committees. The Chairman of the Finance Committee is elected at the annual May meeting of the Board of General Purposes for the ensuing year.

In addition to the Grand Master, D.G.M., S.G.W., J.G.W., Grand Secretary and Grand Treasurer (by virtue of their offices) the remaining members are appointed annually, for a one year period, from the members of the Board of General Purposes. The Vice-Chairman is elected by the Committee from the members.

Quarterly meetings are held to transact such business as may be required, with additional meetings held as deemed necessary.

Following input from the various Grand Lodge Committees and working with the Grand Secretary and Grand Treasurer, the Budget Committee (chaired by the Vice-Chairman of Finance) prepares the annual Grand Lodge operating and capital expenditure budgets. These are then presented to the Board of General Purposes for consideration and to the Annual Communication for appropriate action.

The Committee conducts an ongoing review of the Grand Lodge finances with periodic comparisons of the income and expenses to the approved budgets. The auditor's report is received and reviewed by the Finance Committee for presentation to the Board of General Purposes at their May meeting and then to the next Grand Lodge Communication.

This Committee is also responsible for the hiring of paid Grand Lodge officers, negotiation of remuneration for the paid officers and other duties associated with paid employees.

The Committee annually reviews the policy governing the travel expenses for the Grand Lodge Officers, with any recommended changes presented to the Board of General Purposes for consideration.

#### DID YOU KNOW?

### Edmonton has a Masonic Cemetery!

In 1914, ten lodges joined together in purchasing 60 plots from the City of Edmonton as a Masonic Cemetery. The area is in the shape of an "oblong square". There are twenty plots still unused after 75 years of operation. In 1975 the management was turned over to the Masters', Wardens' and Deacons' Association, through whom plots are available under three circumstances: a) a particular lodge of the original ten has a plot; b) you are a member of that lodge and c) you have taken the first step to the Grand Lodge Above.

## TOPIC OF DISCUSSION

Should the bylaw read to new members be modified or enforced where it relates to profane, irreverent or improper expressions or sentiments?
