Summary of Notices of Motion to 86th Annual Communication

For complete wording readers are referred to printed material in the possession of Lodge Secretaries.

- that an amount of up to ninety thousand dollars from the General Capital Reserve fund be used to retire the current overdraft at the bank thereby releasing the hypothecated bonds presently utilized as security — Finance Committee.
- that a Safety Deposit Box referred to in Section 53 be located in any Financial Institution that is a member of the Canadian Payments Association — Finance.
- that the Auditor appointed by the Annual Communication may be a Chartered Accountant, a Certified General Accountant or a Certified Management Accountant Acme Lodge No. 60.
- that the order of precedence for Grand Lodge Officers be adjusted to place the Senior Grand Warden and the Junior Grand Warden before the District Deputy Grand Masters — Mosaic Lodge No. 176.
- that the title of "Honourable Brother" be created and granted to appointed Grand Lodge Officers who have not attained the rank of an Installed Master — Saskatchewan Lodge No. 92.
- that Lodge of Research be established in the Constitution and be exempted from voting at Grand Lodge Communications Saskatchewan Lodge No. 92.
- that all Master Masons who have been elected or appointed to an office in their Lodge and have registered their attendance may be entitled to vote at any Communication but Past Masters shall be restricted to one vote — *Kitchener Lodge No. 95*.
- that the Lodges be informed on March 1st of the current calculation of the Per Capita Fee to be incorporated into the following December 31st Return — West Edmonton Lodge No. 101.
- that the determination of the Per Capita Fee be made as of October 1st rather than January 1st each year — Centennial Lodge No. 194.
- that an elected District representative replace the District Deputy Grand Master on the Board of General

- Purposes and that the Grand Master not have the power to appoint additional members—*Calgary Lodge No. 23*.
- that the wording be clarified as to the time lapse between a petition for initiation being read in Lodge and the report of the committee — Jurisprudence Committee.
- that an application for a Demit be referred to an investigating committee to determine the member's reason for leaving the Craft Membership Committee and C.O.M.E.L.Y. Program.
- that authority be granted to form Masonic Boards of Relief in areas where there are four or more Lodges — Zetland Lodge No. 83.
- that provision be made for the collars and jewels of officers in Lodges which have been continuously chartered for 100 years to be finished in gold — Edmonton Lodge No. 7.
- that permission be given to Lodges to determine the free distribution of 25 year lapel pins and to produce commemorative Masonic Pins for sale — Finance Committee.
- that a Ritual Master's Jewel be authorized for presentation to a qualified member of the Craft for proficiency in presentation of the ritual Norwood Lodge No. 90.
- that the Committee on the Work change the penalty of E.A. Degree to read "...a cable's length from shore..."
 — Calgary Lodge No. 23.
- that the Committee on the Work change their current ruling and permit a collection to be taken after the completion of the Northeast Corner lecture but not during the lecture — Calgary Lodge No. 23.
- that the present Constitution be repealed by the adoption of a new Constitution and Regulations as approved by the Board of General Purposes SP2 Committee.

Calgary Masonic Board of Relief

The Calgary Masonic Board of Relief is one of the oldest committees in the history of Calgary Freemasonry. The Board administers a fund to assist indigent Masons, or their families, who are from outside this jurisdiction (whether now resident in Alberta, visiting or travelling through). This assistance could be of a monetary or nonmonetary nature.

For the most part, Lodges publish the names of their representatives to the Board in their Lodge Notices. These representatives have authority to act immediately on situations of distress when encountered. Alternatively, the Board can be contacted through the Grand Lodge office or directly through its Chairman, W.Bro. Don Buck, Calgary Lodge No. 23 (Res. 242-6495 Bus. 279-8333).

We should not take a timid approach to our answers. We should not indicate a desire to "change the subject." We should not reflect "mums the word" attitude. Instead, we should be prepared to speak with ease, pride and authority. Make known that Freemasonry is a way of life. Freemasonry is a fraternal organization, religious in character, based on the belief in the Fatherhood of God, Brotherhood of Man and the immortality of the soul. Be prompt to make it known that Freemasonry is not a "secret society" as many may surmise. Freemasonry is a voluntary association wherein the interested one comes of his own free will and accord. Discussions on religion or politics have no place in our proceedings. Proclaim that Freemasonry, in its every effort and purpose, strives to do charitable work within its membership and for society and, through its teachings, seeks to make good men better men. You can proudly state that the basic ethical principals as exemplified in our ritual and Lodge work, are such as are most acceptable to all good men: they are lessons based on the golden rule, tolerance toward men, respect for ones family, charity towards all and being true to God for His gracious and numerous blessings. Be proud to proclaim that Freemasonry is a band of men bound together in the bonds of Brotherly Love and Affection that extends throughout the World. And to sum it all up, Freemasonry is kindness in the home, honesty in business, courtesy in society, fairness in work, pity and concern for the unfortunate, resistance toward the wicked, help for the weak, trust in the strong, forgiveness for the penitent, love for one another and, above all, reverence and love for God. These and many other answers can be applied to the questions your friends will ask. Speak up. What do we have to hide — save that which pertains to our esoteric work? Freemasonry is a way of life.
