- 1) AGENDA: The Annual Communication under provision of the Constitution and Regulations R1.01.03, will be conducted by MW Bro. Ray Burton from the attached Agenda, governed by the rules of order as per the Regulations and/or those listed in the Preliminary Report. The Grand Master may revise the Agenda R1.01.04.
- 2) NOTICES OF MOTION: The complete list of Notices of Motion to amend the Constitution and Regulations will be presented through the Report of the Board of General Purposes.
- 3) **REGISTRATION**: Shall commence in the foyer of the Red Deer Lodge Courtyard Inn at 8:00 AM, Friday, June 2, 1995. Balloting will be suspended at 6:00 PM as recommended at the Board of General Purposes, or subject to change by will of the craft. Registration will reopen at 8:00 AM, Saturday, June 3, 1995 and close at 10:00 AM that morning.

BALLOTING: Shall commence at 9:00 AM, June 2, 1995 and will be available during the same hours as Registration. BALLOTING will be declared closed at 10:00 AM, June 3, 1995.

NOMINATIONS: A list of the names of those Brethren nominated for Grand Office, Boards and Committees, as per section R1.2 of the Regulations, is attached.

Who May And Should Attend Grand Lodge?

All Worshipful Masters and Wardens are expected to attend the Grand Communication. All Past Masters and other elected and appointed officers are voting members and are encouraged to attend. Remember that this is the meeting at which all business of the Grand Jurisdiction is discussed and decided. In addition, Master Masons are most welcome to attend all the events listed on the agenda. Remember that it is no good saying "Grand Lodge decided to do such-and-such" and blame the Grand Officers those who make decisions are the WMs, PMs, Wardens, and elected and appointed officers ONLY! Are they armed with the wishes of the Lodge on all important issues? If not, it is important that the Lodge recommend to its representatives who it prefers in ballots, and also what it would like as the outcome of the Notices of Motion. The absence of any input from your Lodge needs to be corrected by your Lodge. Without your current and past officers, your Lodge has no voice in the affairs that affect you and, last year, 37 of our 145 Lodges had no representation of any of their three senior officers!

1995 Annual Communication

These are the Notices of Motion received in the Grand Lodge Office. Please note that these have not been approved by the Jurisprudence Committee.

Amendments To The Constitution And Regulations

1. I will move, or cause to be moved, that an addition be made to Section C11.01 of the Constitution by the addition of the words:

"The Editor of the Grand Lodge Bulletin"

These words to be added below the list of other exofficio members from Boards and Committees.

Moved by RW Bro. Norman Senn Seconded by MW Bro. Robert Juthner.

2. From Edmonton Lodge No. 7

Whereas the Grand Lodge of Alberta recognizes and authorizes the Work to be conducted in either the Canadian Rite or the Ancient York Rite;

Whereas it is in the best interests of both practicing Rites that the Work be performed and maintained, as closely as possible, to the Original and Traditional forms; and

Whereas these results can best be achieved by close observation and research into these original forms;

Hereby it is moved that Article C11.3 of the Constitution of the Grand Lodge of Alberta, A.F. & A.M, G.R.A., be amended to read as follows:

C11.03 — There shall be a Committee on the Work, who shall be the custodians of the Work, and comprised of the following members:

The Grand Master

The Deputy Grand Master

Grand Secretary

Chairman, (appointed as per C11.01.13)

Eight (8) members appointed by the Grand Master, who have demonstrated abilities in Ritualistic matters:

Four (4) of whom shall be from Lodges practicing the "Canadian Work" who shall comprise the Subcommittee on the Canadian Rite Work (2 from the northern half of the jurisdiction, and 2 from the southern half)

and

Four (4) of whom shall be from Lodges practicing the "Ancient York Work" who shall comprise the Subcommittee on the Ancient York Work, (2 from the northern half of the jurisdiction, and 2 from the southern half).

C11.03.01 — As is; and C11.03.02 — As is

To amend Regulation 1.07.09 Committee on the Work — subject to the passing of the motion to amend Constitution, Article 11.03.

R1.07.09.03 — amended by the addition of the following clause at the end of this regulation...

"Each of the Sub-committees shall interpret and rule upon the Work of the Rite it represents."

R1.07.09.09 — Seven (7) members shall constitute a quorum for the Committee, which shall include three members of each Rite.

Three (3) members shall constitute a quorum for each Sub-committee.

3. From Edmonton Lodge No. 7

Whereas the average age of the membership of the Grand Region of Alberta is approximately fifty-six (56) years;

Whereas it is obvious that in almost every case, any prospective members sponsored by existing members, will undoubtedly be someone of an age near to his sponsor;

Whereas it is also obvious, that in order to reduce the average age, we need and must have a massive influx of young applicants below the age of 25 (maximum);

Therefore, it seems to follow, that we must find ways and means to encourage that influx of young men who will then be able to find and sponsor others of their age groups.

It is Hereby Resolved that Article C19.22 of the Constitution of the Grand Lodge of Alberta be amended as follows: (NFW)

C19.22.07 — "LEWIS" — the Son of a Mason of the full age of 18 years;

C19.22.08 — "DeMolay" — DeMolay Members of the full age of 18 years, under the following conditions:

C19.22.08.01 — that he will maintain his active membership and participation in DeMolay until his 21st birthday;

C19.22.08.02—that he will be made an Entered Apprentice on approval of his application, and will remain an E.A. Mason for a minimum of 18 months, after which he may be passed to the Degree of a Fellowcraft, and remain a F.C. Mason until his 21st birthday, when he may be raised to the Degree of Master Mason.

C19.22.09 — Initiation Fees for Lewis or DeMolay members will be 20% of the initiation fee of the Lodge into which he is initiated. The balance of the prescribed fee will be paid by the G.L. Benevolent Fund — 40% and the Lodge will forego the last 40%. The dues for these members shall not exceed the total of the Grand Lodge assessment per member per year, plus membership costs to the Lodge to a maximum of \$50.00 per year. On being made a Master Mason all fees revert to regular members' fees.

In the event that the motion to amend Article C19.22 is passed, to amend Regulation R3.07.01 as follows:

R3.07.01.03 — to read; "A candidate must be of the full age of twenty-one years or qualify under the terms of Constitution Article C19.22.07-08, at the time of signing"...etc.

R3.07.01.10 — to read; "The petition shall be accompanied by the initiation fee required by the by-laws of the Lodge, or in accordance with Constitution Article C19.22.09

R3.07.01.11 — to read as is but with the following added clause; "except in accordance with Constitution Article C19.22.09"

and to Amend Regulation R3.09 as follows:

R3.09.08.01—to read; "He shall be liable for the regular Lodge dues on pro-rate basis from that date, or for dues as specified in Constitution Article C19.22.09."
