Editorial "Masonic Model" Gaining Momentum

A most worthwhile endeavour of social action on the part of Freemasons evincing our teachings of the "Brotherhood of Men under the Fatherhood of God", is in full swing south of the border and now also across the sea. The majority of our Alberta Brethren may have never heard about it. Here it is, in a nutshell:

The "Masonic Model" Student Assistance Training was developed by the Grand Lodge of Pennsylvania and has, by the fall of 1996, been adopted by sixteen other Masonic jurisdictions - in the words of WBro Lawrence Chisholm, Executive Director of the (US) National Masonic Foundation for Children - as their "flagship" substance abuse prevention program. This program is designed to teach teachers, school administrators, counsellors, nurses, even school janitors or cafeteria workers in some cases, to look at *children at-risk* differently. Those who have been through "Masonic Model" Student Assistance Training know how to recognize the tell tale signs of children in need and they know what to do to get them help. The people so trained already reported that the system works and that children get the help they need to avoid alcohol and drugs.

Only one example is the Grand Lodge of Illinois where the program is reportedly "bursting at the seams", where they have helped more than 25,000 children in the past five years and spent close to one million dollars, provided by the Freemasons of that state. So far the program has been used in 25 percent of the 900 school districts of Illinois, but Bro G. Daniel Phillips of the Illinois Masonic Foundation receives two or three calls weekly, requesting "Masonic Model" training. He reported, "The problems and needs of at-risk children vary from area to area, but those who only exist to survive in an arena where crime, violence and despair is the norm certainly present a challenge that the "Masonic Model" can meet when we acknowledge the complex nature of the barriers in the lives of inner city children. I am confident that we can meet this challenge once we make the commitment and initiate the process".

Police officers will be among those receiving "Masonic Model" training when representatives from El Dorado County

schools in northern California are trained in 1997. This has already received favourable coverage in the local newspaper. The interest is spreading. Similar success stories come from Pennsylvania, Michigan, Arizona, New York and other jurisdictions.

With all this work done by Masons for purely altruistic reasons, it is nice to note that the light is not hidden under a bushel. The National Masonic Foundation for Children was among selected organizations represented at the "Prevention Through Service" leadership summit meeting at the White House last June which was also attended by senior Clinton administration officials and members of the US Congress. The trend is spreading even farther. Now the Senate of the United Grand Lodges of Germany (which consist of five member grand lodges, three working in German and two in English) has decided to establish a foundation, adapting the "Masonic Model" Student Assistance Training to the German culture. Two Brethren, personally known to this editor, are instrumental in bringing this program to Germany. One is their GM, MWBro Rainer Schicke who had learned about the program at the Conference of Grand Masters of North America and, enthused, met with the president of the Federal Republic of Germany to put the pieces in place to bring the "Masonic Model" to Germany. The other is RWBro Jess Minton, PGM and Grand Secretary of the American-Canadian Grand Lodge (within the UGL of Germany), who said, "It's working out" and also noted that no other organization in Germany is offering anything resembling "Masonic Model" Student Assistance Training. Even with the ranks of the American-Canadian Grand Lodge somewhat depleting because of military deployments to Bosnia, a recent celebration of the 50th year of English-speaking Freemasonry in Germany, raised about 12,000 DM (US\$7,500) to support substance abuse, but the topic has as yet not been elevated to a "theme" to be pursued by the Freemasons of Alberta. Can we learn from the example of our Brethren abroad?

Book Review

Albert Pike — The Man Beyond The Moment James T. Tresner II

(Available @ US\$12.99 postpaid from California Research Lodge, Box 6587, Buena Park CA 90622)

Up front, this biography admits that the historical Albert Pike has a reputation clouded by his detractors. His authorship of *Morals and Dogma* has long provided fodder to the enemies of Freemasonry to the degree that through disinformation and misrepresentation, the public image of Freemasonry itself is wrongfully sullied.

Unfortunately, even Masons have difficulty with *Morals and Dogma* to the point that only the most interested student of Pike takes the trouble to find out more about Albert Pike, the Man.

It is more than a chronicle of his life in a somewhat unique style. Pike's opinions, principles and ideals are presented and analysed in a clear and very readable manner. Albert Pike was an amazing man. He was a teacher, musician, frontiersman, lawyer, judge, soldier, philosopher, author and a poet, to identify some of his more noted accomplishments.

But Albert Pike, the Man, is more than a list of credits. For example, living in Arkansas during the Civil War/Reconstruction Era, Pike openly opposed slavery. He abhorred prejudice and intolerance, yet believed strongly enough in the right of states to secede. An example of fortitude worthy of imitation.

Today, it is easy to forget that Pike was a public personage and very popular. It is easier to think of Albert Pike for his accomplishments in Scottish Rite and Masonry in general than to see him as he really was. The constant attack on his Masonic views by those panderers of a personal agenda making Doubting Thomases of many. It is ironic that a man of such high moral standards should be the subject of character assassination by the self-righteous.

This book is long overdue. It brings our thinking up-todate by recalling the real character of one of the most prominent men of the nineteenth century. It also corrects the erroneous impressions of one of Masonry's guiding lights and gives each of us a view of the real Albert Pike. It is a book every Mason should read before and after reading *Morals and Dogma*. *The Montana Masonic News*, December 1996

Notices of Motion To Amend The Constitution and Regulations Presented By Lodges and Committees 1997

Constitution

Lethbridge Lodge No. 39:

- AMEND the Constitution of the Grand Lodge of Alberta.
- WHEREAS: The York Rite Ritual states in closing:
 - "How should Masons meet?"
 - "On the Level"
- WHEREAS: To simplify the introduction of visitors.
- WHEREAS: There is insufficient distinction between current and past Grand Lodge Officers.
- WHEREAS: Other major jurisdictions do not affix the Grand Lodge and Lodge salutations to the persona but to the Office.
- WHEREAS: Grand Lodge and Lodge salutations are not used in some Lodges within our Jurisdiction except for incumbent Grand Lodge and Lodge Officers.
- THEREFORE, BE IT RESOLVED: That the current Article 6, Section 6.2 of the Constitution of the Grand Lodge of Alberta be renumbered to be 6.2.1; and
- That the following Section be added to the Constitution of the Grand Lodge of Alberta:

6.2.2 All Brethren within the Grand Lodge of Alberta shall only be referred to as "Brother."

When being introduced:

- 1. Those holding a current Grand Lodge Office, will have the full title of their office as listed in Section 6.2.1 appended to their name.
- 2. Past Grand Lodge Officers may either have the word "Past" prefix the name of the office which they held or the name of the office specified followed by the year(s) held.
- 3. Past Masters of a Lodge may have the words "Past Master" appended to their name or "Worshipful Master" with the years(s) being specified.

Section 8.3 be deleted in its entirety.

Meridian Lodge No. 129:

Meridian Lodge No. 29, with respect to the Committee on the Work, proposes amendment to the Constitution and Regulations to affect the following:

- 1. elect 6 rather than appoint 4 members (3 Canadian Rite & 3 York Rite);
- 2. terms of 6 years (1 per year elected) rather than being for an in definite term;
- 3. Committee on the Work to deal with legislation of prescribed Work while DDGMs responsible for control and supervision of the practice of the Work as authorized by the Committee;

by amending in the following manner — deleting the existing

C11.3.1,2.3 and replacing that provision with the following:

- 11.3.1 There shall be a Committee on the Work who shall be the custodians of the Work and comprised of the following members:
 - The Grand Master
 - The Deputy Grand Master
 - The Grand Secretary

Six (6) members, each for a term of six (6) years, who are Past Masters and have demonstrated abilities in ritualistic matters;

Three (3) of whom shall be from Lodges practising the *Canadian Work;* and

Three (3) of whom shall be from Lodges practising the *Ancient York Work*.

.2 One member of the Committee shall be appointed each year,

at Grand Lodge Communications, alternating between the Canadian and Ancient York Work, by the Grand Master at his pleasure when:

- i) the name(s) of Brethren interested in being appointed by the Grand Master are received from respective Lodges, in writing, within ninety (90) days prior to Grand Lodge Communications.
- .3 The powers and duties of the Committee shall be as prescribed by regulation.

By deleting the existing **R1.7.9.2** & replacing it with the following: **1.7.9 Committee on the Work**

The District Deputy Grand Master(s) shall be responsible to the Grand Master for the control, practice and supervision of all ritual and ceremonial work authorized by Grand Lodge. Changes in any authorized Work of practice must take place formally via the Committee on the Work and be sanctioned by Grand Lodge.

From Jurisprudence Committee

Amendments Re: Articles C14 and C19

- 1. Article 14.2 and 14.3 be amended to read:
- 14.2 Past Masters and other voting members who hold more than one elected or appointed office in any Lodge or Lodges will be entitled to one (1) vote only (subject to voting by proxy under **C14.3**) and shall declare and register for one office, in one Lodge, only under which they are claiming their ballot.
- 14.3 Where any of the Worshipful Master, Senior Warden or Junior Warden of a Constituent Lodge are absent from a Grand Lodge Communication, or have registered pursuant to **14.2**, the senior of the three (3) officers in attendance may claim the ballot of such absent officer and vote the same by proxy.

Fiat Lux Lodge of Research No. 1980:

A Motion was proposed to the Lodge that members of Fiat Lux Lodge should not be paying Grand Lodge fees and assessment for their membership in a Research Lodge, and it was duly seconded and carried.

"Paragraph C19.9.5 and C14.3 of the Constitution and Sections R1.4.3 to .7 inclusive, R3.2.12, R3.6.10, R3.6.11, R3.6.17, R3.7.1, R3.9, R3.14.2 to R3.14.5 inclusive and R3.15.3 of the Regulations and any other provision therefore not consistent with Section R3.16 of this Division 3 shall not apply to Research Lodges."

Regulations

Jurisprudence Committee:

To introduce a new section to the Regulations as follows: R1.02.07.01 A member who

- has inadvertently damaged a ballot issued under section 1.02.07 in such a manner as to render it unusable;
- has not previously spoiled a ballot on that election, may return it to the Grand Registrar or his nominee who shall:
- 3. render it a spoiled ballot; and
- 4. issue the member a second ballot.
