The Conference of Grand Masters of North America

Held at Savannah, Georgia, February 20 – 22, 2000

Historic Savannah was the venue for the annual Conference of Grand Masters of North America. Consisting of 64 Grand Lodges, the conference played host to 58 of the member Grand Lodges. Alberta was represented by MWBro Art Jones and RWBro Gerry Webber. Notice was given that the Grand Lodge of Alberta would be submitting a formal bid next year to host the Conference in Calgary in the year 2005, our centennial year. RWBro Webber was elected as Vice Chairman of the conference in 2001.

In addition to the regular annual meetings of the various Masonic related organizations, the conference reintroduced a workshop format. Four individual sessions were presented four times which enabled all in attendance to take part. Subjects covered this year included Public Relations, Conducting business in the First Degree, Membership, and Internet opportunities. Sessions were professionally presented and well-attended. Alberta representatives were able to share their experience and the results from the Foundation for the Future program. Regional conference reports provided an insight into the concerns and priorities of the various regions.

Tuesday morning, as usual, featured the annual Frank S. Land DeMolay Breakfast, which is sponsored by the Imperial Shrine. We were informed that the Order of DeMolay in North America has launched a campaign to initiate 3,000 members during March. We wish them well in this worthy undertaking.

During his speech to the delegates, the Imperial Potentate of the Shrine recorded his concern with the continual loss of members which the Shrine is experiencing. In his opinion, if they are unable to bolster their ranks through the advancement of Master Masons, they might be obliged to go directly to "the street" to recruit members. Needless to say, this possibility startled the majority of the audience but it was agreed in

subsequent discussion that the matter would be monitored and no action was appropriate at this time.

While in Savannah, visitors were able to visit the Lodge room of King Solomon Lodge No. 1, reported to be the oldest, continually operating Masonic Lodge in North America. Their Lodge building was at one time part of the original Georgia Cotton Exchange. Tours of old Savannah helped us to appreciate the historic nature of the area and to appreciate the careful and serious thought which went into the planning of the city. Captain James Oglethorpe, who came from England to oversee the establishment of the settlement, became the first Worshipful Master of King Solomon Lodge No. 1. Southern hospitality was evident everywhere, old friendships were renewed and new relationships established. The conference theme, "Masonry, A Link to the 21st Century," was timely and caused those in attendance to rethink their own individual roles in forging those links.

Editorial

Wherever The Twain Shall Meet

"The Twain" alluded to here are North and South: North and South in the geographical sense, applied to our fair province of Alberta. Far too often this means a division into opposing factions — surely this should never be allowed to enter into consideration by the members of our gentle Craft. In Freemasonry we have so much which unites us, and so little, if anything, that could be divisive. Yet, to please everyone, it had been decided, from the beginning, that the annual communications of the Grand Lodge of Alberta be held alternately in the cities of Calgary and Edmonton. This was soon expanded to admit other urban centres into the picture, albeit strictly observing an imaginary dividing line, something akin to our neighbours' "Mason-Dixon Line" (we wouldn't want to hurt anybody's locally-patriotic feelings, now, would we?).

Very recently another revision has been made, this time to meet two years in a row in the area identified by the telephone area code 403, and then two years in the 780 domain. But that's not all, because now the idea is to branch out into smaller "urbs," not for any reasons of pacifying otherwise neglected localities, but for the more mundane reason that, apparently, much more favourable conditions (in dollars and cents) can be negotiated there, as opposed to the escalating prices charged by big city hotels. This, it is hoped, will attract more Brethren, and their entourage, to attend Grand Lodge.

"The proof's in the pudding" as the saying goes, and we will get our first taste of it this coming June when we will ALL (?) congregate in the city of Camrose. It is still a fair distance to travel from the more remote localities, both in the North and in the South, but will the lower hotel bill do the trick? Will we see the principal officers of all Lodges "attended by a numerous retinue" of Past Masters and Master Masons holding office? Will all Lodges be officially represented? Oh well, one can dream, can't one?

Conclusion of articles on Masonic Protocol and Etiquette.

The preceding seven issues of the *Grand Lodge Bulletin* have carried essays on such topics as "Titles and Forms of Address" in Freemasonry, "On Dress or Clothing" in Lodge, "Behaviour in Lodge" while at work, "At the Banquet" or at "Table Lodge," and "Flag Protocol" as ordained by the Department of Canadian Heritage. The discussion focused primarily on the events which occur during a typical Lodge meeting, that is, in Lodge assembled and at refreshment, but dealt also with special events on the Constituent Lodge level as well as in Grand Lodge.

All pronouncements made in these essays were based on authoritative sources, mostly of Masonic, and some of non-Masonic, origin. The reader interested in these is welcome to request the bibliography from the author. It is recognized that not all "Dos and Don'ts" mentioned will be palatable to all. At the same time, however, such as are cited from the Constitution and Regulations or are taken from the Rulings of the Committee on the Work are not subject to debate. The same applies to quotations taken from a Canadian Government source.

The subject of good manners, or social grace, should not be viewed as one composed of so many "No-Nos," "Don'ts" and "Taboos," all designed to curtail one's enjoyment and the feeling at ease which is so essential for a successful Masonic meeting. Quite the contrary, because pleasant formalities are apt to leave us with positive memories whereas thoughtless, if not rude, informality is more likely to achieve the opposite effect. It has been said that we should not by our awkwardness embarrass, offend or annoy our Brethren. By the same token, those who become aware of these "Dos" and "don'ts" and incorporate the former in their manners and avoid the latter will more fully enjoy their Masonic functions, both in Lodge and at the festive board.

One might say that by the observance of Masonic Protocol and Etiquette we will contribute to the attainment of "the chief point in Freemasonry, namely, to endeavour to be happy ourselves and to communicate that happiness to others."

Proposed Amendments to the Constitution and Regulations

The following Amendments have been received in the Grand Lodge Office and referred to the Jurisprudence Committee for approval as to form and, if in order, referred to the Board to General Purposes. The Amendments to the Constitution and Regulations as approved by the Board of General Purposes will be brought before the Annual Communication of the Grand Lodge of Alberta. The existing Constitution and/or Regulations are indicated in regular type: *Bold and italicized letters* indicate proposed new material to be added to the existing Constitution and/or Regulations.

The following proposed Amendment to Section 2.2.12 is submitted by RWBro Gary Timmons, District Deputy Grand Master, Calgary Highwood District.

12. "Those persons entitled to vote at the Annual District meeting shall be members of the Lodges in the District who are Worshipful Masters, Wardens, Past Masters and Master Masons who hold an elected or appointed Office in their Lodge as registered with Grand Lodge R1.4.8.2. Past Masters who hold an elected or appointed Office will be entitled to one (1) vote only (except as under R2.2.13)".

Motion: A Master Mason shall be allowed to vote at District meetings.

The following proposed Amendment to Section 2.2.9 of the Regulations to allow for the election of a District Deputy Grand Master by acclamation is submitted by Astra Lodge No. 179.

- 2.2.9 Following the close of nominations, as specified in the District Nominating Notice, the District Nomination Committee in the prescribed form with necessary variations:
- .1 may nominate additional qualified members of the Craft for the Office of District Deputy Grand Master for such District,
- .2 shall nominate at least one (1) qualified member of the Craft if there is only one (1) valid nomination received,

Motion: *Whereas* the deadline for nominations for the position of District Deputy Grand Master established in Regulations 2.2.8. is made void by Regulations 2.2.9.1 and 2.2.9.2.; and

Whereas Regulation 2.2.9.1 empowers a non-elected committee to appoint additional candidates after the established deadline without explanation; and

Whereas Regulation 2.2.9.2 removes from the voting membership of the District the democratic right to elect a candidate by acclamation; and

Whereas each of Regulations 2.2.9.1 and 2.2.9.2 permit interference with the normal democratic election process;

Be it resolved that Regulation 2.2.9.1 and Regulation 2.2.9.2 be deleted.

man Masonic Spring Workshop 2000.



Internet Lodge of Research UD



On March 4, 2000, the ceremony of Institution of Internet Lodge of Research UD was held in Bowmont Lodge Hall, Calgary, with MWBro J. Arthur Jones, Grand Master, presiding. The first Principal Officers of this Canadian Rite Lodge are MWBro Hugh Young, WM, WBro Garth Cochran, SW, and WBro Kim Greenizan, JW. The hall was filled to near capacity by members and by visitors from near and far. The Worshipful Master had this to say:

"In the earlier days of Freemasonry, Lodges were formed when Brethren with similar interests outside of Masonry came together. Thus Lodges were formed where the majority of members were travelling salesmen, others where they were lawyers, and so forth. So it is with this Internet Lodge of Research. Twenty-seven Brethren who have common interests in technology and Freemasonry have come together to use their interest in technology to increase their knowledge of Freemasonry and to propagate their knowledge of Freemasonry to enhance cyberspace. As with any new venture, it could only happen because there was a will to make it happen — when everyone said 'Let's Do It!'

"A portion of the Lodge website is devoted to Research Papers written by Alberta Brethren. Submissions are earnestly requested. This can be the Alberta window on the world. An opportunity to show what we can do. Please forward YOUR paper.

"Freemasonry must always live in the present, while protecting the landmarks of the Order, which are timeless. The present is the world at our fingertips through the use of technology. We must embrace this opportunity. The Internet Lodge of Research intends to do so."

Having called off from labour for one hour, the Senior Warden conducted an information session with contributions from other members of the Lodge and live audio messages from like-minded Brethren in Great Britain and Sweden. This proved to be a thorough and instructive treatment of the mechanics of working with the Internet, but did not make any mention of the commitment to and the intricacies of academically sound Masonic Research. An "Alberta Window on the World" cannot rely on papers received from other Brethren in the jurisdiction, or from elsewhere, as the Internet Lodge would have no guarantee that proper research has been conducted. Their own Brethren would have to learn to produce original research, which entails the testing (not proving!) of hypotheses. It is, therefore, important that the further progress of this new Lodge be not rushed, and the Brethren be given the opportunity to prove themselves as serious Re-
