Guest Editorial When in Rome...

In 1995, when I was working as a professional entertainer, I had the wonderful opportunity to travel around the world to South Korea, where I performed my act some 357 times in a span of three months. During this time I had the opportunity to meet many fellow entertainers from around the globe and to learn a bit about their customs. While this was an interesting international exchange of ideas, we were all guests in the city of Tagu and were trying to learn their customs. Inasmuch as was possible, I tried to learn the language, accent, and common gestures of civility. I think I was successful in this and the Koreans were truly appreciative of the effort, for it showed a foreigner's respect for their traditions and history.

Now the reader must ask, what has any of this to do with Freemasonry? I wish I could say that I had attended Lodge while in the country. Unfortunately, I cannot. No, the connection between my South Korean experience and the present Masonic topic boils down to the often quoted phrase, "When in Rome, do as the Roman do."

I was initiated, passed and raised in a Lodge under the Grand Lodge of Canada in the Province of Ontario. It was in my native Ontario that I sat in the East, and it is Ontario that shall always be home sweet home, or at least the "home sweet home" of past memories, for as the poet says: "you can never go home again."

Time and circumstances have now brought me across the country to the Province of Alberta. I remember my first visit to an Alberta Lodge. The fellowship was familiar. The regalia the Brethren wore were familiar. The words of the ritual were identical to what I knew, but there were subtle things that seemed as foreign to me as the customs of the South Koreans, of which I have such fond recollections through retrospective eyes.

As a visiting Worshipful Master, in those early days, I held steadfast to my Mother Lodge's traditions, but at that time I was a member of but one Lodge. As I write this, I am a dues paying member both in the east and here in the west. The time has now come to adopt the subtle nuances of difference that are contained in the work of my new Grand Lodge, the Grand Lodge of Alberta. In fact, Alberta is unique in that there are Lodges that work the Canadian Rite and Lodges that work the York Ritual. These two Lodges work in perfect harmony to one another, albeit with subtle jokes of rivalry between the two. In my Mother Lodge and my new Lodge there is no "due guard," but on any given night I can find myself in a Lodge where there is a "due guard." Although that Lodge may be in Edmonton, rather than Rome, I will "do as the Edmontonians do" and, to the best of my ability, recreate their traditions.

My adoption of the rituals of my new home does not detract from the traditions I was taught and hold in great regard, any more than my adopting the customs of South Korea detracted from my status as a proud Canadian. Then as now, it only adds to the experience of life and I feel my life has been made all the richer for such a diversity of experience. So henceforth my Grand Honours will include a stamp of the foot as well as the prerequisite clapping of the hands. I will perform the due guard when it is required, for at the end of the day, my experience in South Korea taught me that people are just people, no matter where they are found; my experience here in Alberta has taught me that Freemasons are just Freemasons, no matter where they are found.

Right glad can we be for both revelations.

Proposed Amendments to the Constitution and Regulations

Fraternal Relations Committee Resolution

Whereas: At the 97th Annual Communication, MWBro Don Millar moved and seconded by MWBro William Graves that bestowing Past Honorary Status on visitors where the constitution calls for three visits before this is usually done, that the Grand Master may have the prerogative to bestow this honorary title on visitors who come great distances.

Whereas: The Honorary Grand Lodge Appointments was tabled at the 97th Annual Communication and referred to the Jurisprudence Committee for resolution.

Whereas: The Jurisprudence Committee gives Notice of Motion that Article 7 of the Constitution of Grand Lodge be amended by the addition of a new Article 7.8.

Resolution: It is moved by the Jurisprudence Committee that Article 7 of the Constitution be amended by the addition of the under-noted and numbered Article 7.8.

 7.8 "Notwithstanding the Provisions of Article 7.7, the Grand Master may, under special circumstances and in his discretion, grant Honorary membership in Grand Lodge to a Brother of a sister jurisdiction of such rank and distinction, as is merited, on the first visit of the Brother to our Annual Communication."

2. The rest of Article 7 shall be renumbered accordingly.

Jurisprudence Committee Resolutions

Whereas: The Jurisprudence Committee recommends that the Board of General Purposes be reduced from 16 to 15 elected members and each member to be elected for a three year term instead of a two year term;

Whereas: Appointments by the Grand Master to the Jurisprudence Committee from the elected members of the Board of General Purposes (R1.7.6.2) would synchronize with the three appointments to the Committee;

Whereas: The proposed three year term avoids two year appointments to the Finance Committee from the elected Board, who have only one year remaining on the Board. Appointments are generally based on a member's expertise or desire: e.g., lawyers are not generally interested in serving on the Finance Committee;

Whereas: Two year appointments from the elected members of the Board to the Finance Committee results in a pool of 10 Board members with two years plus term remaining on the Board, as opposed to the current situation whereby the Grand Master has only eight members to select from;

Whereas: Election of members to the Board of General Purposes based on District representation provides for all areas of the Grand Jurisdiction to be equally represented;

Resolution: It is moved by the Jurisprudence Committee;

That: Article C11.1 is amended to fifteen (15) elected members, not sixteen.

That: Article C11.1.3 of the Constitution be amended to read "Elected members of the Board of General Purposes shall be elected at the regular Annual District Meeting of each Masonic District. Elected members shall serve a term of three years and no elected member of the Board shall serve more than three consecutive terms. Any elected member of the Board, who absents himself from two consecutive regular meetings of the Board without good and sufficient cause as determined by the presiding officer of the Board, shall be deemed to be no longer a member of the Board.

That: Article C11.1.2 shall read as follows:

C11.1.2 Where a member is:

a. a Master Mason,

b. in good standing in a Lodge within the District for a period of not less than five (5) consecutive years, and

c. a resident of this jurisdiction.

he is eligible for nomination and election to the Board of General Purposes.

That: the Implementation Plan for the proposed changes to follow the under-noted timetable:

During the 2003/2004 Masonic Year: each Masonic District shall elect a member to serve on the Board of General Purposes commencing in the 2004/2005 Masonic Year.

Group "A" (Five Districts) elects a member for one year Group "B" (Five Districts) elects a member for two years Group "C" (Five Districts) elects a member for three years.

During the 2004/2005 Masonic Year:

Group "A" elects a member for three years.

During the 2005/2006 Masonic Year:

Group "B" elects a member for three years.

During each subsequent Masonic Year, each Group elects a member for three years on a rotating basis.

Board of General Purposes Task Force — Study on Committees

Whereas: At the November 21, 2002 meeting of the Board of General Purposes the Jurisprudence Committee reported "Because some committees appear to be redundant, it was recommended to the Board of General Purposes that it review the number of committees, structure and reporting procedures of the same";

Whereas: It was recommended by the Board of General Purposes that the President and Vice President select a small task force to review all committees of the Board of General Purposes and recommend restructuring and redefining the responsibilities and duties of committees:

Whereas: The Task Force, under the chairmanship of MWBro Art Jones PGM, therefore reviewed the sub-committees of the Board of General Purposes to:

- compile a comprehensive list of existing committees;
- examine the activities of each of these committees and compare same to the duties laid out in the Constitution and Regulations of the Grand Lodge of Alberta;
- where necessary, redefine the responsibilities and duties of the committees:
- · eliminate unnecessary areas of overlapping responsibility;
- close gaps in responsibility;
- · identify redundant committees;
- · identify requirements for new committees; and
- establish procedures for committee reports to the Board of General Purposes;

Whereas: Those committees in the Regulations which have been deleted, altered or amended in whole or part and those new committees established and have been presented to the Jurisprudence Committee for review and approval and have received the approval of the Board of General Purposes need only be presented at the 98th Annual Communication through the President's Report on the Board of General Purposes for ratification by the Craft as per Article 17.7.3;

Whereas: Those committees outlined in the Constitution which the Task Force has recommended for deletion, alterations or amendments in whole or part and those new committees established have been presented to the Jurisprudence Committee for review and approval. Following this review and approval a Notice of Motion to amend/alter the Constitution shall be published in the notice of that Communication and must be approved by a two-thirds majority vote by the members present and voting;

Resolution: It is moved by the Task Force on the Review of Committees:

That: The wording in C11.1.12 "The following sub-committees" be changed to read, "There shall be the following **committees** of the Board of General Purposes:"

That: Constitution C11.2 (Board of Benevolence) be transferred to Regulation R1.7.3 which deals with that committee.

That: The "Board of Benevolence" be renamed as the **Committee on Benevolence** and listed in C11.1.12 as Committee of the
Board of General Purposes.

That: a "Chairman" not a "President" chairs The Committee on Benevolence.

That: Any reference in the Constitution and Regulations made to the "Board of Benevolence" and/or "President of the Board of Benevolence" is changed to read the Committee on Benevolence.

That: Constitution C11.3 (Committee on the Work) be transferred to the Regulations R1.7.9, which deals with that committee.

That: with the deletion, renaming and additions of committees to the Board of General Purposes C11.1.12 will read as follows:

Therefore Be It Resolved that The Grand Lodge of Alberta adopt the following gonfalon to be suspended from a crossbar hung

from a vertical pole topped by the square and compasses united in the Fellowcraft position, to be named the Grand Standard, approximately 90 cm in width by 120 cm in height. On the obverse side, at the top there will be a broad "a garter blue" bar with gold lettering: "The Grand Lodge of Alberta — Ancient, Free and Accepted Masons"; alongside both sides there will be garter blue stripes terminating at the bottom in a V-Shape, showing near the bottom on the Dexter side a pink Alberta wild rose with green leaves; and on the sinister side a white, erect polar bear.

The central panel of very pale blue satin will bear the Arms of The Grand Lodge of Alberta, as they appear in the Seal, in gold, silver and coloured metallic thread, and underneath and above its beveled bottom the inscription in gold lettering: Constituted October 12th, A.L. 5905. Centered below a red, stylized Maple Leaf, as in the Canadian Flag. The bottom of the central panel ends in an angle of 120 degrees.

The bottoms of the top bar, side and central panels are enhanced by gold fringe.

The reverse of the Standard shall be of 'garter blue" material, on which will be embroidered prominently, in gold, the jewel of the Grand Master, the compasses extended to 45 degrees with the segment of a circle at the points, enclosing the all-seeing eye within a triangle, both irradiated.

The Standard will be borne at the head of a procession, by the Grand Standard Bearer, on occasions when the Grand Master enters to preside over Grand Lodge Communication or orders this to be done on his fraternal visits and other occasions. (When any other Grand Lodge Officer is representing the Grand Master, the Grand Standard may not be displayed.) When the Grand Master has ascended the East, the Standard will be placed in a convenient location in the Northeast of the Lodge (Grand Lodge), and the Grand Standard Bearer will take his seat nearby.

Furthermore,

Whereas it is the custom among sister jurisdiction that the Standard be borne by an officer of Grand Lodge so designated,

Therefore Be It Resolved that the Grand Lodge of Alberta create the office by appointment of a Very Worshipful Grand Standard Bearer. It shall be the duty of this officer to have charge of the Standard and to be at the call of the Grand Master. He will take his seat near the Standard in the Northeast.

Resolution: It is moved by RWBro Norman Thomas and seconded by MWBro Robert Juthner.

That: In accordance with article C17.2, to amend the Constitution by adding to article C6.2 the office of **The Very Worshipful Grand Standard Bearer**,

That: Article 10 —Powers and Duties of Grand Lodge Officers — be amended by adding:

C10.22 The Grand Standard Bearer shall, except where hindered by necessity:

- .1 Attend all Communications:
- ..2 Lead the Grand Lodge procession when the Grand Master is present, except when the Grand Piper is present, at which time shall follow directly behind the Grand Piper;
- .3 Perform such other duties as the Grand Master may direct.
