Very good for the observant reader; he remembers that at the 100th Annual Communication in June 2005 the Jurisprudence Committee moved that the definition C.0.19 "Voting Member" be amended to read: "Voting Member" means a Worshipful Master, Senior Warden, Junior Warden or Past Master and all Master Masons. The motion was carried, removing the former restriction to Master Masons holding elected or appointed office.

So what's the problem? Maybe it isn't one, but — look here — only the listing of definitions in the Constitution's Article ZERO was amended, **not** the important Article C6.1 cited above! Ouch! Just one more reason that **WE** all be there and share in the responsibility of making wise decisions for the good of the Craft.

Freemasons for Dummies

Christopher Hodapp, 32°, Wiley Publishing Inc., Hoboken, New Jersey, USA

The *Dummies* series has been very successful. The concise and clearly written series has extended its franchise to just about every topic imaginable. I have seen large numbers of books on all aspects of home computing, E-bay, and topics ranging from poker to wines to various games. It is no wonder they finally got around to the Craft.

The author is a member of the Craft, the Scottish Rite, various branches of the Royal Arch, the Shrine, Southern California Research Lodge, the Scottish Rite Research Society, and the Philalethes Society. He has written for the *Indiana Freemason* magazine and is a moderator for *Hiram's Forum*, a Masonic Internet project of the Grand Lodge of Indiana.

The first section, "What is Freemasonry," discusses in very broad terms the concept of the three degrees and what Masons do. This is followed by a brief history of the Craft; Masonry in America; the rise of Fraternalism; the philosophy of Freemasonry; and politics, religion and Freemasonry and how they don't mix. The second section discusses how Lodges work - the officers, Grand Lodges - what they are and do, a brief discussion of our ceremonies, our symbols, and common misconceptions. The third section covers all the appendant (we would say concordant) bodies, including many not usually found in Canada. Part 4 discusses the current state of the Craft and its possible future. Part 5 is a bit of an odd mix. The first chapter in this section discusses ten groups of famous Masons, e.g., Founding Fathers, military leaders, etc. The next chapter discusses conspiracies, anti-Masons, and hoaxes. The last chapter in the section deals with ten interesting Masonic places to visit. This includes Freemasons' Hall in London, House of the Temple in Washington, DC, Rosslyn Chapel in Scotland, and Freemasons' Hall in Philadelphia. The last section consists of appendices. Included here are the Regius Manuscript, Anderson's Constitutions, and finding a Lodge. This last section is interesting because its three parts are "Mainstream US Grand Lodges," "Prince Hall Grand Lodges," and "Canadian Grand Lodges."

Like all books in the series, the book is | Total Payment Enclosed:

an easy read, very concise, and relatively current. It is a handy reference, but does not pursue any of the topics in great depth. While the book is written by an American and primarily for an American readership, the book is very interesting. If anyone has been concerned about how much to tell friends, wives, or prospective candidates about the Craft, this book certainly should help set the limits. It covers the information but discloses none of the Craft's "secrets." I believe that any member of the Craft would find this an interesting read.

Proposed Amendments to the Constitution and Regulations

Jurisprudence

Committee Resolutions:

Resolution #01

At the Grand Lodge Communication in June 2003, the Jurisprudence Committee presented a motion to revise Article C11.1.3 and Article C11.1.2 which effectively read that members of the Board of General Purposes shall be elected at the Regular Annual District Meeting of each Masonic District and that a Master Mason in good standing in a Lodge within the District for a period of not less than five consecutive years would be eligible for nomination.

After a number of years following this procedure it is very apparent that several Districts, particularly those with limited membership, are having great difficulty in finding members to run for election to the position of DDGM for one year, let alone to find somebody willing to serve on the Board for three years. Consequently, there consistently exist several vacancies on the Board. In addition, it has been recorded that a number of members of the Board, who allowed their names to stand for election to fulfill the requirements of the process, do not attend the meetings, are members in name only and are noncontributory to the administrative work of the Grand Lodge.

While the original intent was praiseworthy, the practicality of the matter is that the new process is not working. It is therefore proposed that the Jurisprudence Committee consider bringing the following motions to the floor of Grand Lodge:

Motion #01A

Article C11.1.2 shall read as follows: "Where a member is:

- .1 a Master Mason,
- .2 in good standing in a Lodge within the Jurisdiction for a period of not less than five (5) consecutive years, and
- .3 a resident in this Jurisdiction, he is eligible for nomination to the Board of General Purposes."

Motion #01B

Article C11.1.3 shall read as follows: "Elected members of the Board shall be elected by Grand Lodge at its Annual Communication, five (5) of whom shall be elected each year. Elected members shall serve a term of three (3) years and no elected member of the Board shall serve more than three (3) consecutive terms. Any elected member of the Board, who absents himself from two consecutive meetings of the Board without good and sufficient cause, as determined by the presiding officer of the Board, shall be deemed to be no longer a member of the Board."

Resolution #02

WHEREAS:

- 1. the Jurisprudence Committee ruled that a resolution passed by Grand Lodge, which provided Master Masons with the right to vote at the Annual Grand Lodge Communication, did not apply to District Meetings because a specific Regulation expressly stating that Master Masons did not have a vote at District Meetings could not be overridden by a general motion, and
- due to the misunderstanding of the foregoing ruling Master Masons were, in fact, allowed to vote at District Meetings in the year 2005,

NOW THEREFORE BE IT RESOLVED THAT:

Motion #02A

All motions passed and elections held at each District Meeting in 2005 are hereby ratified by Grand Lodge assembled and deemed valid, notwithstanding the fact that Master Masons were allowed contrary to the ruling of the Jurisprudence Committee.

AND WHEREAS:

 the Jurisprudence Committee has ruled that the Constitution and Regulations as currently exist, hold that Master Masons do not have the right to vote at District Meetings in the future, and 2. it is thought that Master Masons should have the right to vote at District Meetings,

NOW THEREFORE BE IT RESOLVED THAT:

Regulation 2.2.12 be amended to read as follows:

Motion #02B

"Those persons entitled to vote at the Annual District meeting shall be members of Lodges in the District who have attained the rank of Master Mason as registered with the Grand Lodge. Each member qualified to vote is entitled to one (1) vote only."

Resolution #03

The Jurisprudence Committee moves that the Grand Lodge of Alberta have a policy that all prospective candidates for Petition for Initiation or Re-instatement be required to have a *Criminal Records Check* as part of their application for membership, to be sent to the Secretary of the Lodge which they are petitioning.

"Moved that the Grand Lodge of Alberta repeal Regulation R3.9.1 which limits the number of candidates that can be initiated, passed or raised in one (1) day."
