Editorial

Sharing the Words

In his address to the Annual Communication of Grand Lodge in 1935, MWBro Victor A. Bowes recommended that Grand Lodge issue a two or three page monthly bulletin, and that "the main portion be devoted to quotation of interesting and instructive articles or papers of more or less general Masonic interest, to be obtained from Masonic periodicals published throughout the world..." At the same Communication, the Committee on Research and Education reported that during the previous year, 541 addresses of Masonic interest had been delivered in 112 Lodges across the Jurisdiction. The size of the Bulletin, now The Alberta Freemason, has increased over the intervening years, and it now includes more material originating in this jurisdiction. Meanwhile the tide of Masonic Education has continued to ebb and flow.

MWBro J.R. Malcolm Berry, in his Inaugural Address, called for a revitalization of education, exhorting us to

"...Raise the Bar in educating our candidates and, through an ongoing process, the members of our fraternity, not simply in the Q & A and Obligation sections, but in the true teachings of the Craft. Let us always remember, as the General Charge says, to draw aside the veil, or more properly speaking, to penetrate through it, and become acquainted with all the mysteries of Masonry."

Many Lodges have taken this charge to heart, and are making an effort to embed education in the structure of their Lodges and in their Lodge meetings. Rumours abound of fine papers written, of interesting talks given, of sustainable education programs initiated.

This brings us back to the thoughts of a previous Grand Master. MWBro Rod Ponech's theme for 2004–2005 was

From Darkness to Light. Based on the passage (Matthew 5:16):

"Let your Light so shine before men, that they may see your good works, and glorify your Father which is in heaven."

His theme reflected his desire for all Masons to stand up and be proud of their membership, and to communicate this pride to the world. But this theme could also apply to our actions amongst the Craft, and especially to our educational efforts.

Don't hide your Lodge's Masonic light under a bushel. Share those papers, those talks, the resource materials your members have found, so that the whole Fraternity may benefit from your efforts.

We can help you spread that word. We are always happy to receive submissions, and will endeavour to publish them in future issues, either in full or in summary, as long as there is room.

Proposed Amendments to the Constitution and Regulations

Resolution of Rockyford Lodge No. 123 that: Article C 11 Boards & Committees.

Article C 11.1 be changed to read "There shall be a Board of General Purposes comprised of not more than twenty-five members and shall include the Grand Master, the Deputy Grand Master, the Senior Grand Warden, the Junior Grand Warden, the Grand Secretary and the elected members from within the Jurisdiction"

1. The Lewis Jewel be permitted to be worn by a Mason, if at the time of his Initiation, his father was a Mason in good standing (the initiate of a deceased father — in good standing at the time of his demise — would also qualify to receive the jewel.)

- 2. The Lewis Jewel be suspended from two chains, with two bars; the upper bar containing the name of the father and the date of his initiation and the lower bar containing the name of the Lewis, (the son) and his date of initiation.
- 3. That the Regulations and, if necessary, the Constitution of Grand Lodge be amended to permit the wearing of the Lewis Jewel in Grand Lodge and in any Constituent Lodge.

Resolution of Mizpah Lodge No. 35 that:

"The Members of Mizpah Lodge No. 35 petition the 2007 Grand Lodge of Alberta Annual Communication for permission to conduct a one-time only, One-Day Field Day to exemplify the three degrees of Masonry and to replace the usual proving up requirements of all the degrees with proving up questions and the obligation of the third degree only."

A Motion at the Grand Lodge of Alberta held in Medicine Hat in 2005 called for a candidate for the office of Junior Grand Warden to produce a paper of between 500 and 1000 words outlining his vision of Freemasonry in the Grand Jurisdiction. In response to that regulation, the following is respectfully submitted:

In order to respond to such an all encompassing topic as 'My Vision of Freemasonry in Alberta', one is forced to be a little introspective and ask himself first "who am I and where am I?" He must then look at the Fraternity and ask "what are we and where are we?"

We all know that we are a fraternal organization, the aims of which are Brotherly Love, Relief, and Truth. These, I believe, we may express as, and expand into, public and private morality, the knowledge and fear of God and, following on from that, respect for, and love of, our neighbour and

and abilities. For those who do not know me — this essay is one small way to let you know that I have thought long and hard about Freemasonry and am committed to building on what we now have.

Since joining the Craft in 1998 I have carefully watched and listened to those who have led us. I have also listened carefully to brethren in the many lodges I have visited. I have seen over the past decade a marked shift in the way we are proposing to do business in Freemasonry. To be sure, we still have those concerns that will always be there for our organization, issues surrounding the role of the Grand Lodge to the constituent Lodges, the broader role of how we relate to society in general, asking questions of and ensuring that we do business according to the Constitution and the never-ending questions of being financially responsible, to name just a few.

These are important governance issues that our past and current leadership have addressed and continue to deal with. My commitment is to use my skills in these areas to continue on the path that has been set. However, while these are important issues, there is something far more critical facing us as an organization, something that for me is the most fundamental thing that I have to offer the Craft if I were to be elected as Junior Grand Warden.

Let me say first that I have noticed a shift in attitude over the past few years. It used to be that all we talked about was the current state of Freemasonry reflected in declining numbers and limited involvement by our members. Now, while there still are membership challenges in many of our Lodges, it seems the greatest challenge we face is how to integrate into our Lodges the many men that are joining us. My firm belief is that we are on the front end of this trend and that it will continue to accelerate. As this happens, it will offer the largest governance concern of all; just how do we train our individual Lodges to be ready for the men who will join us so that they will stay and experience a meaningful membership. One critical focus for me would be to oversee a practical educational format that addresses our current Grand Master's theme of "raising the bar", corporately and individually. This effort is absolutely essential and is one area that I have had the pleasure of working on extensively.

And yet, while I am sensitive to the magnitude of this task, there is another area of focus that for me is even more essential. Anyone who knows me has heard me argue that we need to develop a clear vision of Freemasonry that works for each one of us; it is a message that I have tried to articulate on many occasions. Simply, it is rooted in this understanding; we raise the bar of our lives when we truly internalize why the bar should be raised. Awareness is the first step in the process. If, as Masons, we do not clearly understand our role in the broader scope then we may not have the motivation required to change or "raise the bar" of our selves and our Lodges.

Those who developed the brilliant system of speculative Masonry — a system for understanding personal change like no other — did so with intention. For them there was rhyme and reason for encouraging the betterment of the self. For them, the transformation of the individual using the teachings of our rituals was done with the intention of effecting change in all around us. This, then, for me, is the mission statement of Freemasonry: transform the self for the transformation

fellow man. This respect includes toleration of his personal viewpoint, his religious beliefs and his political opinions. All these concepts must be protected by the Grand Lodge as fundamental to our very nature.

In the three hundred years from the creation of the first Grand Lodge of England, our fraternity has weathered many changes in the makeup of our society. Nothing however can rival those changes that have occurred in the past fifty years. For one, there have been massive population moves from towns and villages to huge cities inhabited by millions of people. There have been amazing transformations in musical, literary, architectural, and artistic forms, in building materials, as well as changes in political and economic structures.

Our Fraternity itself has experienced massive changes. The phenomenal growth that occurred at the end of the Second World War and which in some way paralleled a similar growth a generation earlier was the result of thousands of men, just out of uniform, and comfortable with male only societies, finding themselves attracted to Freemasonry. Not necessarily for our traditional moral values but rather for the friendship and the sense of belonging that our fraternity naturally offers. Yet this growth had the effect of changing the direction of our Craft from one that had been a social conscience to one that was socially conscious. If we are to offer the Mason of today a meaningful experience we must strive to recapture that spark of social responsibility, that willingness to discuss issues of the day and attempt to do something about it.

This remarkable growth produced a demographic bubble, a cohort that marched through the years. One that as its members passed to the Grand Lodge Above or simply drifted away from Freemasonry created a larger and larger deficit in our population numbers. This in turn caused the whole Craft to become obsessed with our statistical reporting and enrolment. It now appears that we may have turned the corner and for the first time in many years we have seen real growth in this jurisdiction. Nevertheless for several years, we have known that our initiations have outnumbered our deaths; where our difficulty has always rested was not recruitment but retention of the new brethren. This is not new in Freemasonry nor is it new in our jurisdiction but it is essential that in the future we focus our efforts on this situation and attempt to improve our retention record.

It has been identified by American research work into this problem, that there is a very strong inverse relationship between the amount of disposable leisure time that any particular pursuit requires and its popularity with individuals. People nowadays have a very limited amount of free time due, often, to very heavy demands by their profession or occupation, and this leisure time must be rationed out sparingly to avoid competition with family and other priority interests. Any pastime which makes substantial demands on time available, or which is not perceived to give a fair return — however that may be measured subjectively — will not be favoured and, in Masonic terms, this will be evidenced by reduced attendance.

When asked what would entice attendance, Masons in the states of Maryland, Kansas, Missouri and California who participated in a recent survey in the main replied that they would like more Masonic education. They would also like to see regular attendees be more sensitive to the embarrass-

of the world. My focus will be to encourage all Freemasons to think carefully about this mission of Freemasonry for it provides us with the reason for what we do.

In many ways our sense of mission is not new or unique in philosophical or religious traditions. What is unique with us is the way we define the process. Good men want to become better in their lives. Good men also want to contribute in a meaningful way in what they do. We have the raw material to help "good men become better". What we need to work on now is providing the framework at the Lodge level that will engender this process. With understanding comes necessary action. When we are working at the Lodge level to encourage that understanding then the growth we have started to see will increase exponentially. There just is no other alternative.

It is exciting to be part of this process at this time. My commitment, whether Junior Grand Warden or not, is to continue to encourage this process to move forward. I do thank you for the chance to share some of my thoughts and feelings and ask for your support at our Grand Lodge convocation.

ment non-attendees may feel upon returning to lodge after prolonged absence. Others wanted more family activities, more involvement in community affairs, more entertainment at meetings, a more relaxed atmosphere, less formal dress at meetings, and more interesting meetings. Many questioned the time spent opening and closing Lodge and in the business part of the evening. These issues must be addressed by the Lodges themselves but perhaps there is a role that Grand Lodge might play.

There is no doubt that Lodges that provide a good educational programme have much more success at attracting and retaining members. For some Lodges, improvement of their programme is hampered by the lack of resource availability. Grand Lodge could have a role in developing a comprehensive programme of Masonic Education including development of educational and instructive materials that might be disseminated to Lodges.

Planning is essential in a successful Lodge. The Grand Lodge must encourage and provide tools for lodges to establish a planned year's program, develop increased activities, and to have meaningful and interesting agendas for their communications and other programmes

We must help to develop technology resources to make better use of the current technology in the administration of lodges and dissemination of information to our members and to the public. We could, for example, look at our current Web site with a view to determining if there is a way to ensure that each Lodge has a capability to have a site that they could easily maintain.

We must try to demonstrate to the world at large, thereby hopefully making our Order more attractive to all would-be members, that Freemasons carry the message of love, peace, and understanding which prevails in our small society to the greater society of mankind. Therefore, we must continue with and reinforce our public relations program and image.

We must review the district structure of our Grand Lodge with a view to making it more efficient and effective and equal. We should investigate ways to establish a more meaningful program of support for Masonic Youth Organizations

Freemasonry is a fairly stable product in itself — very little can be done to alter the product without changing it entirely in both essence and appearance. Its principles and precepts have stood the test of time and are as valid today as ever. We cannot change the product and remain in the same business; and we must be true to ourselves in this. What we have and what we stand for will always be right, even if its acceptance rises or fails on the scales of time.

Report on the Conference of Grand Masters of Masons in North America

Portland, Oregon, 18, 19 & 20 February 2007

The Conference was attended by the Grand Master, the Deputy Grand Master and the Senior Grand Warden of the Grand Lodge of Alberta, while the Grand Secretary attended the concurrent Conference of Grand Secretaries. A total of 57 of the 64 North American Member Grand Lodges were in attendance as well as numerous representatives of Grand Lodges from South America, Europe and the rest of the world, giving the Conference a truly international flavour while specific issues concentrated on North America.

Of significant interest was that so many of the Grand Jurisdictions reported a resurgence of interest in Freemasonry and were experiencing an influx of members in the 25- to 40-year age bracket. Neither is this phenomenon confined to the North American Continent one might add.

As well as the usual annual meetings of the several committees, breakout discussion sessions were held on such topics as Masonic Responsibilities/Officer Training, Long Range Planning Techniques, Public Awareness, Masonic Mentorship and Education to name but a few.

The Committee on Information for Recognition, a body that examines submissions from Grand Lodges throughout the World requesting recognition by the Member Grand Lodges of North America, was particularly interesting. With the resurgence of interest in Freemasonry a number of new

Grand Lodges are being formed throughout the world, some, unfortunately, in conflict or opposition to existing Grand Lodges. The International Masonic Traveller would be well advised to check with his Grand Lodge Office to ascertain that his Mother Grand Lodge recognizes such Lodges he may be planning to visit.

Altogether the Conference was once again stimulating and enlightening, and one cannot fail to come away without a deeper understanding and appreciation of this great fraternity we call Freemasonry.
